'Story of rape after spiked drink difficult to believe'

Mumbai: A sessions court has held it disbelieved the story of a 34-year-old complainant who has accused singer-actor Karan Oberoi of initially raping her by administering some intoxicant as well her accusation that he had videotaped the act and extorted money by threatening to circulate the video. Oberoi was arrested on May 5.

The Dindoshi sessions court had, on May 17, rejected his bail plea stating it would not be appropriate to grant bail

"at this stage". The order, which was out on Tuesday, states, "The story in respect of sexual intercourse by administration of intoxicating substance is difficult to believe for the reason that the informant is said to have left for her house soon after the incident. The story in respect of extortion under intimidation to make the video go viral is also difficult to believe looking to the fact that the informant continued to give gifts to applicant from time to time.
