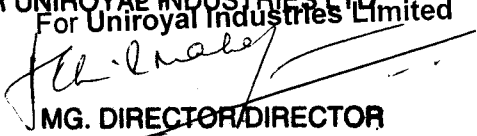

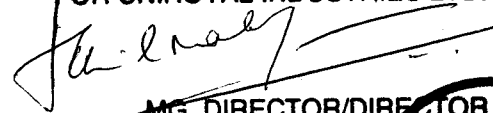

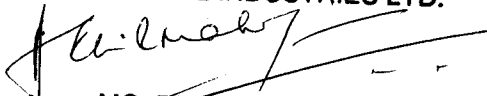

I am glad that my association with the company as an Independent Director was rewarding and fruitful.

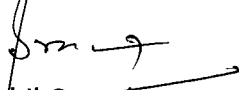
