The company has been in operation with minimal permitted staff. The Company has not faced any material adversity of its financial position as at 30 June 2020 and considering other relevant facts and circumstances existing as of that date, the Company does not anticipate any material uncertainties which affects its liquidity position and also ability to continue as a going concern. However, the impact of the global health pandemic may differ from that estimated as at the date of approval of the financial results and the Company will continue to closely monitor any material changes to future economic conditions.
- The company is operating under one segment hence segment reporting is not required.

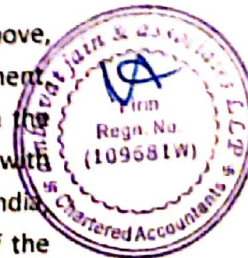

1.
