The consolidated unaudited financial results include the interim financial results of the subsidiary which have not been reviewed by their auditors, whose interim financial results reflect total revenue of Rs. Nil, total net profit after tax of Rs. 0.7 million and total comprehensive income of Rs. 0.7 million for the quarter ended March 31, 2026, as considered in the consolidated unaudited financial results. The consolidated unaudited financial results also include the Group's share of net profit after tax of Rs. 32 million and total comprehensive income of Rs. 32 million for the quarter ended March 31, 2026, as considered in the consolidated unaudited financial results, in respect of associate based on its interim financial results, which have not been reviewed. 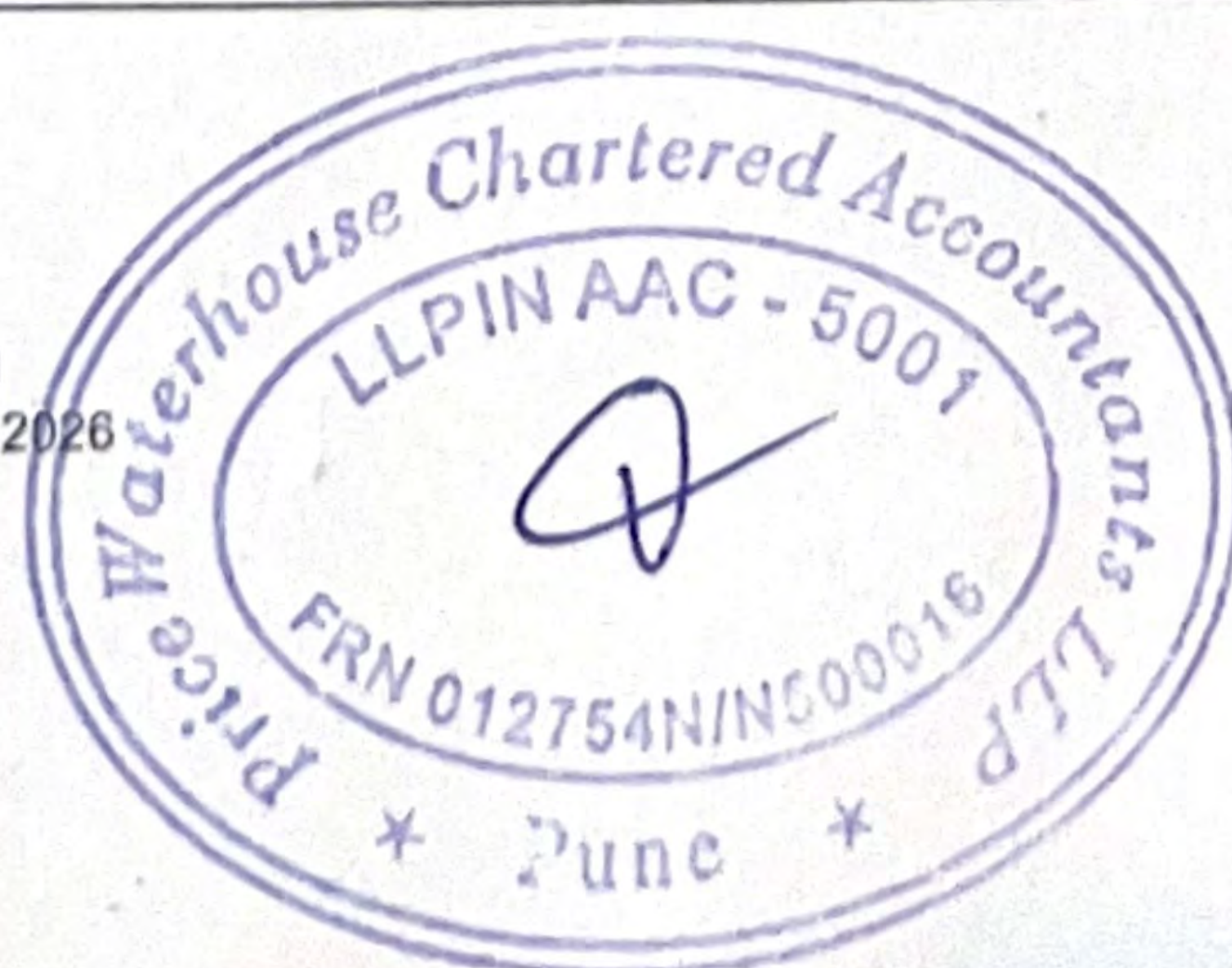

Sub: Resignation as statutory auditor of KSB Limited

We refer to our appointment as statutory auditor of KSB Limited (the 'Company') for a period of five years (financial years 2022 to 2026) at the annual general meeting held on May 11, 2022.

Based on an email dated April 15, 2026, by Mr. Mahesh Bhawe (Chief Financial Officer), the management of the Company is desirous of appointing the same firm of chartered accountants as its auditors, who are affiliated to the auditors of the intermediate holding company outside India. Accordingly, as requested we are resigning as auditor with immediate effect.

We thank the Company for the cooperation extended during our tenure as statutory auditor.

Please note we issued our audit report dated February 25, 2026, on the standalone and consolidated financial statements for the year ended December 31, 2025 and the limited review report dated April 30, 2026 on the unaudited standalone and consolidated financial results for the quarter ended March 31, 2026, prior to our resignation.

Please find attached in Annexure A the information to be obtained by the Company from the auditor for the resignation as required by Securities and Exchange Board of India Master Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024.
