The Delhi Government approves the empanelment of four agencies to carry out Tree Transplantation in the Capital

NEW DELHI : Environment Minister Shri Gopal Rai said that under the leadership of Chief Minister Shri Arvind Kejriwal the Delhi government brought the ambitious Tree Transplantation policy last year. Shri Rai further said that after rigorous research and study the Environment Department of the Delhi government has approved the empanelment of four agencies to carry out Tree Transplantation in the Capital

The four agencies are Green Morning Horticulture Pvt. Ltd. Hyderabad, M/s Rohit Nursery, New Delhi, M/s DD MEP Engineers, Gurugram, and RP Entrepreneurs. To carry out transplantation from any project site in Delhi, the applicant shall be required to select an agency from among the empanelled agencies only. The "Tree Transplantation Policy (2020)" which was notified late last year mandates that trees will not be removed unnecessarily in development projects/works and the es-

ing trees in the project site shall be properly preserved through careful planning, design, implementation and post-construction maintenance. In the event of the possibility of on-site preservation being not viable at least 80% of the trees shall be required to be scientifically transplanted. At least 80% survival of the transplanted trees after completion of a year from the date of transplantation is mandatory. If transplantation is also mandated by the Tree Transplantation Policy.

NEW DELHI : Aam Aadmi Party's senior leader and MLA Atishi issued the "Vaccination Bulletin" through a video address on Monday. Delhi has received not even a single extra dose despite the universal campaign being launched from today. The centre failed even when

they decentralised and asked the states to procure vaccines but refused to deliver, and now too when they have centralised the campaign. Centre's vaccination campaign is only for advertisements and announcements, the reality is that Delhi has not been supplied even a single dose today, when a universal campaign was supposed to be launched. Centre will be making merely 15,19,000 doses available in July. At this speed Delhi will take more than 13 months to

vaccinate its population. Sheer mismanagement and mismanagement by the Central Government in vaccination campaign; we keep on getting new policies but no vaccines; the shortage continues to persist. The centre has still not allowed WHO approved vaccines like Pfizer, Moderna & Johnson & Johnson; but keeping that about mass vaccination, is this a joke made by them? Delhi has 8,27,000 lakh vaccines for 45+; 5 days stock of Covaxin and 57 days stock of Covishield. For 18-44, we have 1 day's stock of Covaxin and 13 days' stock of Covishield. Aam Aadmi Party's MLA Atishi said, "Today is 21st June, and it was announced by the Central Government that from 21st June, for the entire country and for everyone above the age of 18, vaccination would be provided by the Central Government and every person eligible for the vaccination would be vaccinated."
