

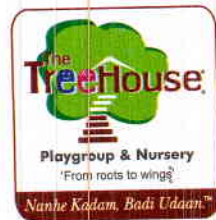

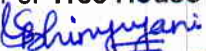
- declaring the closure of the QIP today i.e. December 18, 2014;
- determining and approving the issue price of Rs. 440/- per Equity Share, which reflects a discount of Rs. 15.58 (i.e. 3.42 %) on the floor price of Rs. 455.58, for issuance of [45 45,454] Equity Shares, to be allotted to eligible qualified institutional buyers in the QIP; and
- approving and adopting the placement document dated December 18, 2014 in connection with the QIP (the "Placement Document").
