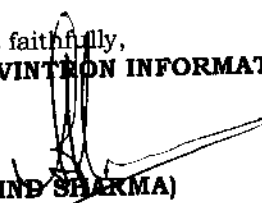

Rahul plans yatra to reach out to workers

New Delhi, 12 August

Outfoxed by veterans who are back in the limelight, former Congress chief Rahul Gandhi and young leaders close to him are planning to connect with party workers on the ground and are preparing to embark on a nationwide yatra.

The initial plan was to retrace the route of the 'sadbhavana yatra' that Rajiv Gandhi had undertaken in 1990. The Congress, under Rajiv's leadership, had lost the Lok Sabha polls a year earlier. So, in a bid to reconnect with the people at large, he had travelled to several cities across India in second-class rail compartments.

The official beginning of the

campaign from August 20, the birth anniversary of his father, to connect with party workers.

Apart from Rahul, leaders like former Lok Sabha MP Meenakshi Natarajan are also preparing to follow their leader's example to travel across India in sleeper class coaches to connect with the people and Congress workers.

There are discussions within his team if Rahul should visit pilgrimage spots that Hindus consider holy, or areas that were venues of key events during India's freedom struggle.

This includes the Mahatma's birthplace in Porbandar, Bardoli, where Sardar Vallabhbhai Patel led a farmer's agitation, or Gandhi's ashram in Wardha.

Rajiv, during his campaign, visited Ayodhya in October 1990,
