Subject: Outcome of meeting of board of directors held on Friday, May 29, 2026.

Re.: Consideration of request received from M/s. Vistara Network Private Limited, Promoter for seeking reclassification of status as public under Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Sir/Madam,

In terms of Regulations 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the meeting of Board of Directors was held on Friday, May 29, 2026, the board of directors considered the request from M/s. Vistara Network Private Limited, presently classified as Promoter of the Company, seeking reclassification from Promoter category to Public category under Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Board, after due deliberation of the request for reclassification, found that the promoter seeking reclassification does not satisfy the condition prescribed under Regulation 31A(3)(b)(i) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, which inter alia provides as under:

“the promoter(s) seeking re-classification and persons related to the promoter(s) seeking re-classification shall not:(i) together, hold more than ten percent of the total voting rights in the listed entity;”

Further, it is also observed that M/s Vistara Network Private Limited, being a promoter entity, holds 15.61% shareholding and voting rights in the Company on a direct basis, which is more than of the of 10% of the total voting rights in the Company. Accordingly, the said entity does not satisfy the condition prescribed for re-classification under Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In view of the above, the request submitted by M/s Vistara Network Private Limited for re-classification from ‘Promoter’ to ‘Public’ category could not be approved and is accordingly rejected by the Board of Directors.
