With reference to SEBI Circular CIR/CFD/CMD-1/142/2018 dated November 19,2018 regarding disclosure of reasons of delay in submission of financial results by the listed entity, we wish to inform the investors of the Company and Stock Exchange that due to fire accident occurred at plant of the Company situated at Zenith Compound, Khopoli, Raigad – 410203 which has already been intimated to stock exchange on 12<sup>th</sup> July, 2019, the Company will not be able to submit the Un-audited Financial Results and Limited Review Report for the quarter ended June 30, 2019 by August 14, 2019 i.e. the due date for submission of Financial Results for the relevant quarter.

Since, the head office and the plant are situated in the adjoining building, the working was disrupted by fire and hence, it is taking longer time than expected to finalise the results. However, the Company is taking adequate steps to finalise the results and the un-audited financial results for quarter ended June 30, 2019 will be submitted on or before September 30,2019.
