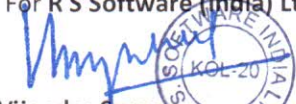

Summary of proceedings of the 29th Annual General Meeting:

The 29th Annual General Meeting (AGM) of the Members of R. S. Software (India) Limited ('the Company') was held on Friday, July 21, 2017 at 11.30 A.M (IST) at Rabindra-Okakura Bhawan, Paschim Bangla Academy, 27A/1 DD Block, Salt Lake City, (Near City Centre I, Salt Lake), Kolkata-700 064.

Mr. Rajnit Rai Jain, chaired the meeting. The requisite quorum being present, the Chairman called the meeting to order. All the Directors of the Company except Mr. Rajasekhar Ramaraj were present at the meeting. The Chairman delivered his speech.

The Chairman further informed that the Company had provided the Members the facility to cast their vote electronically, on all resolutions set forth in the Notice. Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes at the end of the meeting through Polling Papers.

The following items of business, as per the Notice of AGM dated April 19, 2017, were transacted at the meeting.

1. Adoption of Audited Financial Statements (including Consolidated Financial Statement) of the Company for Financial Year ended March 31, 2017 and Report of the Board of Directors (the "Board") and Auditors thereon.
2. Reappointment of Mrs. Sarita Jain (holding DIN 00206743), who retires by rotation and being eligible seeks re-appointment.
3. To appoint M/s Deoki Bijay & Co. Chartered Accountants (Registration No. 313105E) as the Statutory Auditor of the Company and to fix their remuneration.
4. Reappointment of Mr. Rajnit Rai Jain (holding DIN 00122942) as the Chairman & Managing Director of the Company.

Clarifications were provided to the queries raised by the members.

The Board of Directors had appointed Mr. Mohan Ram Goenka as the Scrutinizer to supervise the e-voting and voting process through polling paper. The Chairman authorized the Company secretary to declare the results of voting.

The scrutinizers report was received and accordingly all the resolutions as set out in the notice were declared as passed.
