Telcos Seek Clarity on Name Display in Caller ID

Operators ask DoT how to handle business and family connections

New Delhi: India's top telecom operators have written to the Department of Telecommunications (DoT) on displaying caller details related to business and family connections as part of calling name presentation (CNP) service being tested by them.

The telcos are currently doing inter and intra-circle trials on CNP and have faced queries from consumers regarding certain points. "We have written to the DoT to clarify on business and family connections and what name should be displayed," said an executive working with one of the firms.

Since business connections are issued in the name of the company and not individuals, the company name, the brand name or the individual. Similarly, in family plans, multiple numbers are taken by one individual and used by entire family members, so it needs to be clarified if the individual who is using the number should be displayed or the person who has taken the connection.

For certain business connections, the firms want to display

Other major issues, which is not recognisable by the users.

Queries sent to Reliance Jio, Bharti Airtel and Vodafone India remained unanswered at the time of going to press.

The confusion arises as under CNP, the details of customer acquisition form (CAF)

are displayed as caller details and not the person who is actually using the number. As the telcos are currently doing trials on the technology, the government would take a call on implementation timelines after conclusion of such tests.

On the basis of the outcome of such trials and assessment by telecom service providers, the government shall take decision on implementation of CNP service in mobile networks," minister of state for communications P. Venkatesh Chandra Sekhar informed Parliament last month.

The DoT has been pushing the telcos to implement the CNP service at the earliest. The plan to make name display compulsory for incoming calls is meant to curb spam and scam calls as the recipient of calls will be able to know who is calling. But technological constraints have prevented the implementation of this service on 2G networks, according to telcos.

In February last year, the Telecom Regulatory Authority of India (Trai) had called on the government to mandate telcos to implement the CNP service and push handset manufacturers to enable the feature in six months in a bid to reduce customer harassment from unknown or spam callers.

SC to Hear Plea on Consolidating Online Gaming Cases at 3 HCs

New Delhi: The Supreme Court on Thursday agreed to hear on Monday the Centre's plea seeking transfer of petitions challenging the Promotion and Regulation of Online Gaming Act, 2025, from three high courts to the apex court to avoid conflicting judgments.

The Ministry of Electronics and Information Technology (MeitY) has sought transfer of three pending cases from the high courts of Karnataka, Delhi and Madhya Pradesh to the Supreme Court on the grounds that different HC may deliver conflicting judgments on the same Central law creating legal uncertainty. A consolidated hearing before the apex court would ensure uniformity of judicial pronouncements.

The Centre's petition seeks transfer of cases filed by Heed Digital Works (pending before Karnataka HC), Bagheera Carrom (OFC) pending before Delhi HC and Clubbino 11 Sports & Entertainment (pending before Madhya Pradesh HC).

"Due to multiple litigations pending before various high courts involving the same or substantially similar questions of law and challenging the vires of the same impugned Act, it is imperative that these matters be transferred to this court or any one high court to avoid divergent opinions or multiplicity of proceedings," the plea stated.

SoftBank Pares Stake in Ola Electric to 15.7%

Japanese investor pares holding from 17.8% via multiple deals over past two months

Bengaluru: Masayoshi Son-led SoftBank Group has trimmed its holding in electric scooter maker Ola Electric to 15.7% from 17.8% by offloading 2.15% over the past two months, according to its stock exchange filing on Thursday.

Softbank, the second-largest shareholder in

the Bengaluru-headquartered company after founder Bhavish Aggarwal, sold 19.4 million shares through multiple transactions between July 15 and September 1, 2025.

The filing did not disclose the sale price of the shares.

Other major investors in Ola Electric include Tiger Global Management, Alpha Wave Ventures, and ZAT (former-

ly Matrix Partners India). Both ZAT and Tiger Global, early backers of the company, also pared their holdings between

April and June this year. ZAT offloaded less than 1% stake, earning up to ₹187 crore, while Tiger Global's Internet Fund II cut its stake to 3.24% at the end of June 2025 from 3.45% three months earlier.

In June, Hyundai Motor Company and Kia Corporation had offloaded around 10.8 crore and 2.7 crore shares, re-

spectively, raising ₹552 crore and ₹137 crore.

For the June 2025 quarter, Ola Electric's operating revenue nearly halved year-on-year, while net losses widened as sales were weakened by intensifying competition in India's electric two-wheeler market. The company's revenue fell by 47% to ₹428 crore in Q1 FY26. Vehicle deliveries also dropped to 68,192 units during the quarter, down from 1,25,398 units a year earlier.
