Notes:

- 1 The above results were approved by the Board of Directors in their meeting held on 19 October, 2011.
- 2 Based on technical evaluation and past experience, the Company has changed the estimated useful life of some of its assets w.e.f. 01.04.2011. Accordingly, the written down value of these assets as at the beginning of the year is being amortised over the remaining useful life, in accordance with the provisions of Accounting Standard (AS) 6 on 'Depreciation Accounting' and the assets capitalised during the quarter under this class of assets have been depreciated based on the revised useful life. As a result of this change, depreciation for the quarter and the half-year is lower by Rs. 355.99 lakhs and Rs. 771.46 lakhs respectively with corresponding impact on net profit before tax.
- 3 Since the Company operates in a single segment of Natural Gas Business, the disclosure requirements as per Accounting Standard 17 "Segment Reporting" are not applicable to the Company.
