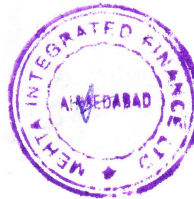

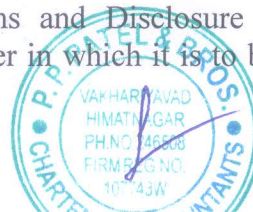

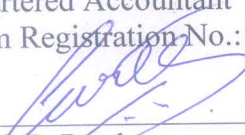

Review Report to,
