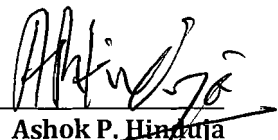

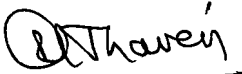

I submit my Report as under:

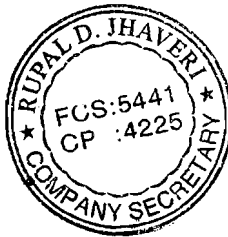
