The aforesaid rating revision is primarily on account of deterioration in the financial profile marked by low cash accruals resulting in low debt protection metrics, high receivables from other entities, delay in commissioning 132 KV transmission line and exposure to regulatory risks.

The rating assignment factors, interalia, experience & track record of promoters, Company's distribution capacity, operational efficiency marked by low Transmission & Distribution losses and consistently improving collection efficiency coupled with fully metered supply.
