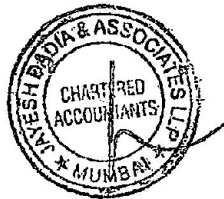

### **Introduction**

We have reviewed the accompanying Statement of standalone Unaudited Financial Results ("the statement") of Morarka Finance Limited ("the Company") for the quarter ended 30<sup>th</sup> June, 2022, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended including various circulars issued by SEBI from time to time.

### **Scope of Review**
