Council of Ministers observes two minutes silence in memory of Archana Mahanta

DISPUR, AUG 28 /- In view of the sudden death of veteran singer Archana Mahanta, the meeting of the Council of Ministers headed by chief minister Sarbananda Sonowal held at Assam Administrative Staff College in Guwahati today, expressed deep condolences and observed silence for two minutes. Chief minister Sonowal

also expressing his condolences called the singer's son Angarag Mahanta, talked to him, expressed his profound grief, and emphasised with him at the testing time. Sonowal's legal advisor Shantam Bhaari on behalf of the government was present at the last rites of the late singer which were performed with full state honours. (DIPR)

Nagaland principal secy briefing on COVID-19

KOIHMA, AUG 28 /- A total of 32 COVID-19 positive cases have been detected on Thursday and the total number of positive cases in the state now stands at 3,784. Active surveillance and contact tracing is also in progress to prevent further spreading of the infection. Out of the 3,784 positive cases, the total active cases are 1,031 and there are 8 deaths. As per the severity of symptoms, 1,015 active cases are asymptomatic. 15 active cases are mild and 1 active case is symptomatic. Further, out of the 3,784 positive cases, the distribution across various categories of people is 1,622 cases of Armed Forces, 1,222 cases of Returnees, 260 cases of Frontline Workers, and 680 cases of Traced Contacts. A total of 35,979 samples have been sent for testing through RT-PCR and the results of 35,371 samples have been received. In addition, a total of 22,483 samples have been sent for testing on Truenat. A total of 1,203 persons are presently under Facility Quarantine. (DIPR)

Surveillance and monitoring on lumpy skin disease in the state

KOIHMA, AUG 28 /- The Directorate of Animal Husbandry & Veterinary Services has informed that there has been a report on 'emerging' of Lumpy Skin Disease in the neighbouring state of Assam.

The Lumpy Skin Disease is caused by the Poxviridae family virus characterised by physical form as or on the skin. The disease is characterised by the presence of lymph nodes with mortality ranging from 1-3 per cent.

However, it causes huge economic losses in the form of drop in milk production, reduced skin quality and restriction of trade/movement. In view of this, the

Department has requested all CVOs to be on high alert by carrying out strict monitoring on the occurrence of the disease in the state through the Veterinary Institutes in respective districts.

Further, the Department has instructed all district officers to issue a not alert instruction to all the Check Posts within their jurisdiction for control of suspected animal movement. Furthermore, the CVOs of Peren, Dimapur, Kohima, Mokochung, Longleng, Mon has been requested to send the report of disease outbreak, if any, to the directorate immediately. (DIPR)

Punjab Police raids ex-DGP Sumedh Saini's house

CHANDIGARH, AUG 28 /- A Punjab Police team raided the house of former state DGP Sumedh Singh Saini here in the early hours of Friday in a case related to the disappearance of a person after a terrorist attack on him in Chandigarh in 1991. However, Saini was not found there, officials said. The raid was launched a day after a Mohali court reserved its order on an anticipatory bail plea filed by the former Punjab Director General of Police (DGP) in this case. On August 21, the court had allowed the Punjab Police to add a murder charge against Saini in the case. The move came after two former Chandigarh police personnel, who are also co-accused, turned approver in the disappearance case. The former Punjab DGP was booked in the month of May this year in connection with the disappearance of Balwant Singh Multani, who was a junior engineer with Chandigarh Industrial and Tourism Corporation. Multani, who was a resident of Mohali, was picked up by police after the terrorist attack on Saini, who was then the senior superintendent of police in Chandigarh. In 1991, according to the FIR, Saini and six others were booked on the complaint of Balwant Multani's brother, Palwinder Singh Multani, who is a resident of Jalandhar. (PTI)

Former NIA ASP booked for 'fraudulently' obtaining CDR of mobile numbers

NEW DELHI, AUG 28 /- The CBI has booked former National Investigation Agency (NIA) ASP Jalaj Srivastava for obtaining call details records (CDR) and analysis from Vodafone in an alleged fraudulent manner. Officials said today. The agency acted on a complaint from the NIA, which sought action against Srivastava, now posted in his parent cadre - Border Security Force - they said. After getting the complaint, the CBI sought a sanction from the home ministry to book Srivastava. It booked Srivastava after getting the ministry's nod. The agency has alleged that between 2017 and 2018, working as an Additional Superintendent of Police (ASP), Srivastava abused his official position to procure the CDR of two mobile phone numbers on two occasions and tried the same for the third time but failed, the officials said. It is alleged

that Avinash Kaur, who used to live in the same building as Srivastava, had asked him to obtain the CDR of one Sudesh Saini, they added. Saini did not have any connection with any case filed by the NIA, the officials said. (PTI)
