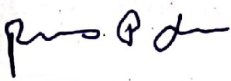

HDFC Q1 profit falls 2% YoY to Rs 3,001 cr, misses estimates; NII up 22%

New Delhi India's biggest mortgage lender HDFC on Monday reported a 1.6 per cent year-on-year (YoY) decrease in standalone net profit at Rs 3,000.67 crore for April-June quarter of FY22 (Q1FY22) on the back of lower other income and higher tax and employee expenses. In the year-ago period, the profit stood at Rs 3,051.5 crore. The number missed Street expectation, which had estimated up to 9 per cent YoY rise in PAT. Analysts at Nomura, for instance, had pegged HDFC's net profit at Rs 3,318.5 crore while those at HSBC projected the same at Rs 3,253.6 crore, suggesting a rise between 7-9 per cent YoY. Sequentially, the profit declined 5.6 per cent from Rs 3,179.83 crore. On a consolidated basis, profit after tax stood at Rs 5,311 crore as compared to Rs 4,059 crore in the previous year, representing a growth of 31 per cent.

The profit before tax for the quarter ended June 30, 2021 stood at Rs 3,905 crore compared to Rs 3,607 crore in the previous year.

On the revenue front, the lender's net interest income (NII) came in at Rs 4,147 crore for the quarter under review, up 22.2 per cent compared with previous year's NII of Rs 3,392 crore. On a quarterly basis, the income increased marginally by 2 per cent from Rs

4,064.8 crore reported in Q4FY21. "Inclusive of income from assigned loans, the NII for the quarter ended June 30, 2021 stood at Rs 4,414 crore compared to Rs 3,576 crore in the previous year, representing a growth of 23 per cent," the NBFC said in a statement.

Net interest margin, meanwhile, was at 3.7 per cent. At the end of the June quarter, HDFC's assets under management (AUM) stood at Rs 5.74 trillion, relative to Rs 5.31 trillion at the end of June, 2020 quarter.

"As at June 30, 2021, individual loans comprise 78 per cent of the total AUM. On an AUM basis, the growth in the individual loan book was 14 per cent and growth in the total loan book was 8 per cent," it said.

It added: The demand for home loans continues to remain strong and disbursements have picked up with the unlocking of respective locations. While disbursements during April and May of the current financial year were somewhat impacted, business has reverted to



normalised trends in the months of June and July. July 2021 disbursements were the highest ever in a non-quarter end month.

NPA and provisioning
HDFC said its gross non-performing loans as at June 30, 2021 stood at Rs 11,120 crore, equivalent to 2.24 per cent of the loan portfolio. The GNPA ratio in Q4FY21 stood at 1.98 per cent. Besides, it carries provisions

worth Rs 5,778 crore. Of this, Rs 2,443 crore is towards provisioning for standard assets and Rs 3,335 crore is towards non-performing assets. The provisions as at June 30, 2021 stood at Rs 13,189 crore.

Meanwhile, the collection efficiency for individual loans on a cumulative basis in June 2021 stood at 98.3 per cent compared to 98 per cent in March 2021.

"Individual NPAs increased due to slippages on account of the impact of the second wave of the pandemic. Collection efforts were hindered due to the recovery teams being unable to do field visits during the lockdown period. Further, various court orders temporarily curbing recovery efforts of financial institutions, including refraining possession activities under SARFAESI hampered the collection efforts," HDFC said in a statement. The scrip of HDFC rose over 1 per cent at Rs 2,472 apiece on the BSE post result announcement as compared to a 0.68 per cent rally in the benchmark S&P BSE Senses.

Gold, silver prices: Yellow metal slightly dips, silver jumps on MCX | Latest rates here



Rs 33 or 0.05 per cent. On Friday, both the precious metals were trading on the lower side on the MCX. While gold futures stood at Rs 48,281 per 10 grams, silver was at Rs 68,100 per kg, witnessing a dip of Rs 192 or 0.28 per cent. Gold and silver prices on the international market: Gold prices eased on Monday as the dollar held steady. Prices retreated from a two-week peak in the previous session after the dollar recovered, according to Reuters.

Spot gold fell by 0.2 per cent to \$1,809.21 per ounce. Meanwhile, U.S. gold futures fell by 0.1 per cent to \$1,814.90. Furthermore, silver fell by 0.4 per cent to \$25.37 per ounce, while platinum gained 0.6 per cent to \$1,054.72. Last week, gold's physical demand was subdued in India as rising prices discouraged retail purchases, while top consumer China saw some safety buying, though jewellery sales were dull. In India, gold and silver rates largely depend on the international prices and are calculated keeping the latter as a basis. Other factors like the USD to INR conversion rate, the supply and demand of gold and silver in MCX trading also play a key role in determining the prices of these precious metals.

New Delhi After witnessing a dip on Friday, gold prices have again witnessed a downfall while silver futures were trading on the higher side on the Multi Commodity Exchange (MCX) on Monday.

Recording a dip of Rs 51 or 0.11 per cent, gold futures maturing on October 5 stand at Rs 47,951 per 10 grams. Meanwhile, silver futures maturing on September 3 are retailing at Rs 67,812 per kg, after witnessing a slight hike of

Birla tells govt he is willing to give up promoter stake in Vodafone Idea

Mumbai Kumar Mangalam Birla has told the government he is willing to offer his stake in Vodafone Idea Limited (VIL) to any state-owned or "domestic financial entity" to keep the stressed telecom company afloat.

Birla, VIL's promoter and chairman of the Aditya Birla Group, made the suggestion in a letter to union cabinet secretary Rajiv Gauba on June 7. VIL has a debt of around Rs 1.8 trillion, which includes deferred spectrum obligations and adjusted gross revenue liabilities. Its board had last September announced a plan to raise Rs 25,000 crore but investors have not been forthcoming in the absence of government support.

Birla's letter highlighted the need for urgent measures from the government while offering to give up control of the company. "It is with a sense of duty towards 27 crore Indians connected by VIL, I am more than willing to hand over my stake in the company to any entity-public sector/government/domestic financial entity or any other that the government may consider worthy of keeping the company as a going concern," Birla said in



his letter. Birla owns over 27 per cent stake in VIL, while Vodafone Plc holds over 44 per cent. The current market capitalisation of VIL is over Rs 24,000 crore. The two promoters have decided against infusing fresh funds in the company. Vodafone Plc has already written off all its investment in VIL following continuous "To actively participate in the fund raising, the potential foreign investors want to see clear

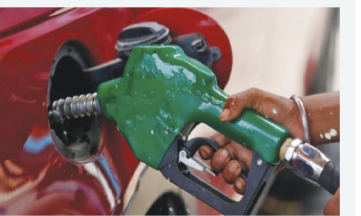
government intent to have a three player telecom market (consistent with its public stance) through positive actions on long-standing requests such as clarity on AGR liability, adequate moratorium on spectrum payments and most importantly, a floor pricing regime above the cost of service. In the absence of definitive steps in this regard, the potential investors have understandable hesitation to invest," Birla wrote.

Birla further said that VIL's financial situation will drive its operations to an irretrievable point of collapse without immediate active support from the government on these three issues. Last month the Supreme Court dismissed petitions of VIL and Bharti Airtel seeking correction in alleged errors in calculating the AGR. VIL had calculated its remaining AGR dues at around Rs 21,500 crore after making a payment of Rs 7800 crore. However, the department of telecommunications concluded the company's total AGR liability of around Rs 58,000 crore.

Petrol, diesel prices unchanged for 16th straight day. Check details

New Delhi Petrol and diesel prices remained unchanged on Monday despite a slight drop in international crude oil prices. Fuel prices have not been hiked by state-run oil marketing companies for the 16th consecutive day. Although fuel prices have not been hiked, both petrol and diesel rates remain at record at all-time highs across the country. There is a high possibility that fuel rates will remain elevated this month as well.

As of today, petrol is retailing at Rs 101.84 per litre in New Delhi and over Rs 107 per litre in Mumbai. The price in Kolkata and Chennai remains above Rs 102 per litre.



There are at least 25-30 cities where petrol price has crossed the three-figure mark. Diesel prices have also increased sharply over the past two months. At the moment, a litre of diesel is retailing at Rs 89.87 per litre in the national capital, while it costs over Rs 97 per litre in Mumbai. The price in Kolkata remains above Rs 93 per litre, and it has crossed Rs 94 per litre in Chennai. The sharp rise in fuel prices has severely hit the household financials of poor families, who are struggling to cope with rising inflation, triggered by rising fuel prices. It may be noted that higher fuel prices have led to a sharp rise in the costs of many essential products. Despite the burden on citizens, the government has made it clear that it is not in a position to decrease the excise duties levied on petrol and diesel. It is worth noting that India levies the highest taxes on fuel in the world. Even state governments have said clearly that they will not be able to reduce the value-added tax (VAT) collected on petrol and diesel. In such a situation, the only relief citizens can get will come through petrol and diesel rate revisions by OMCs. However, such a possibility has also been shrouded as global oil prices remain elevated.

Glenmark Life Sciences IPO falling, Why?

Glenmark IPO Allotment Date, Glenmark Life Sciences IPO GMP: Glenmark Life Sciences is a subsidiary of Glenmark Pharmaceuticals. Glenmark Life Sciences IPO listing date is August 6.

New Delhi Glenmark Life Sciences IPO GMP is falling. Glenmark Life Sciences share price in the grey market is trading below a premium of Rs 100 apiece which is roughly around 15 per cent. The fall in Glenmark Life Sciences GMP is because of the poor earnings of pharma

companies. The sector's result sent Nifty Pharma index to a level last seen in May 2021. The continued sell-off in the pharma sector pushed the pharma index below the 14,000 level. This is the main reason why Glenmark Life Sciences IPO GMP is falling consistently. However, the current pharma stocks sell-off is said to be a short-term correction.

Glenmark Life Sciences is a subsidiary of Glenmark Pharmaceuticals. It is a leading developer and manufacturer of select high-value, non-commoditised active pharmaceutical ingredients (APIs) in chronic therapeutic areas, including cardiovascular disease, central nervous system disease, pain management, and diabetes. The company also manufactures and sells APIs for gastro-intestinal disorders, anti-infectives, and other therapeutic areas.

Glenmark Life Sciences IPO worth Rs



1,513.6 crore received bids for 66,33,24,160 shares against 1,50,18,279 shares on offer. Qualified Institutional Buyers (QIBs) portion received 36.97 times subscription and non-institutional investors a whopping 122.54 times. In the retail category, Glenmark Life Sciences IPO was subscribed 14.63 times.

The initial public offer comprised a fresh issue of up to Rs 1,060 crore and an offer for

sale of up to 63 lakh equity shares. Its price range was at Rs Rs 695-720 per share. Glenmark Life Sciences earlier raised Rs 454 crore from anchor investors.

Glenmark Life Sciences shares were quoting at a premium of Rs 100. The shares were trading at Rs 820 apiece, a 14 per cent premium over IPO price.

Glenmark Life Sciences IPO Allotment Glenmark Life Sciences will finalise the allotment of IPO on August 3 (Tuesday). Glenmark Life Sciences shares will be listed on the BSE and NSE on August 6 (Friday).

Glenmark Life Sciences said that the proceeds from the fresh issue will be used towards the payment of outstanding purchase consideration to the promoter for the spin-off of the API business and funding the capital expenditure requirements.
