I hereby resign from the position of Company Secretary of Pervasive Commodities Ltd. effective from 30.04.2026

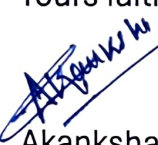
I have decided to step down from my role to pursue better career opportunities and further professional growth.
