CIVIC POLLS ON APRIL 26

Bhavnagar drama: Former BJP corporator joins Cong, returns to saffron-fold hours later

Ahmedabad, April 6

AMID INTENSE political activity ahead of the April 26 local body elections in Gujarat, Bhavnagar witnessed an interesting turn of events on Monday with a former BJP corporator joining the Congress and returning to the saffron-fold hours later.

While joining the Congress, former BJP corporator Sejal Gohel, 30, alleged that she was not feeling safe in the BJP despite being a corporator. Speaking to media persons, she also raised the menace of bootleggers in the city.

Sejal, belonging to the Scheduled Caste community, was a BJP corporator from Ward No 3 of the Bhavnagar Municipal Corporation between 2021 and 2026.

After returning to the BJP hours later, Sejal said she was beguiled by some Congress leaders, a charge denied by the party.

Speaking to The Indian Express, Sejal who is Class XII passout, said, "I was a bit beguiled by some Congress leaders and committed the mistake. I did that under their (Congress leaders') impression. But when I realised my mistake, I returned to the party (BJP)."

Asked about the Congress leaders who allegedly beguiled her, Sejal claimed that she does not know the names.

President of Bhavnagar City Congress Manoharsinh Gohil rejected Sejal's allegations.

"She (Sejal) had come to us on her own volition. She was in our contact for the past 3-4 months. We never called her.

She came to me yesterday along with two of our ward leaders. I told her that she could join Congress, but we would not be able to give her any commitment (including that of giving her a party ticket)." Manoharsinh Gohil told The Indian Express.

"She herself admitted that the reason behind joining Congress was her own safety concerns. We have never tried to tell her what to speak to the media. We did not even try to call her even afterwards. Whatever pressure she might have faced, only she would know," Gohil said.

The elections in 15 municipal corporations, 84 municipalities, 34 zilla panchayats and 260 taluka panchayats in Gujarat are scheduled on April 26 and the results will be declared on April 28.

2025 FATAL STABBING AT AHMEDABAD SCHOOL

‘Was continuously bullied by victim’: High Court grants bail to 14-year-old

Court takes into consideration probation officer's report; notes CCL was threatened with consequences

NOTING THAT he had been subjected to constant bullying by the victim, the Gujarat High Court has granted bail to a minor who allegedly stabbed one of his older schoolmates, which led to his death at a school in Ahmedabad last year.

The child-in-conflict-with-law (CCL) was 14 years and 9 months old at the time of his arrest August 22, 2025, in connection with the offences punishable under Section 109(1) (attempt to murder) and 103(1)



(murder) of the Bharatiya Nyaya Sanhita (BNS).

While granting him bail, the court took into consideration the probation officer's report, which observed that the CCL had been "continuously" bullied by the 16-year-old victim.

Considering the instances of interactions between the two minors cited in the probation officer's report, the court order noted: "The conversation, which took place between the present CCL and the deceased child, as reported by the probation officer, would show that since one month prior to the incident, the deceased child

was putting the CCL under pressure to the extent that the deceased child had threatened the CCL to face the consequences, in case he complained to the teacher.. The probation officer's report suggests that since the day of such a threat, the CCL had been keeping a knife with him..."

Noting that the CCL was a "school going child", the court order states, "The present CCL is ordered to be released on bail... on the applicant's father executing a personal bond to the sum of Rs 10,000..."

The court order noted that the report of the probation officer had described the details of the circumstances under which the incident took place on August 19 last year, resulting in the death of the Class 10 student by alleged stab wounds the following day.

"...The probation officer, in his opinion, has noted that since the child is below the age of 16 years, he is required to be kept in an observation home, and he requires institutional

counselling, and that the counselling process is in progress..."

The HC directed the probation officer to monitor the conduct of the CCL and submit a quarterly report before the Board or the Children's Court until the completion of the trial.

During the submissions in court, the advocate appearing for the CCL had stated that Section 15 of the JJ Act will not apply to the applicant in the present case. Under Section 15, the Juvenile Justice Board is empowered to make "preliminary assessment" for CCL in the age of 16 to 19 years, accused of heinous offences to ascertain if the CCL had the mental and physical capacity for the commission of such crime, following which, the Board is mandated to pass an order that the CCL—aged between 16 and 18 years—can be tried as an adult. The advocate appearing for the applicant in the case submitted that the 'mental and physical capacity of the CCL below the age of 16 years would not be a matter for consideration."

Two arrested for theft of LPG cylinders from snack shop

ATA time when LPG cylinders have become high valued commodity, the Vadodara City Detection of Crime Branch on Sunday arrested two men for alleged theft of two domestic LPG cylinders after they were "unable to explain" how they had procured the cylinders. Police added that the accused allegedly confessed to 'stealing the LPG cylinders' from an eatery in Gotri.

The two men were intercepted when they were travelling on motorcycle in the Ajabdi Mill area of the old city area with two domestic LPG cylinders of 15 kg each belonging to Indane Gas. "When the two men were questioned as to where they procured the gas cylinders from, they were unable to give satisfactory answers... The two men confessed that they had stolen the two cylinders from a snack shop in the Gotri area of the city, two days ago," a statement from the DCB said.

Police added that the two--Rahul Waghawala and Siddharth Vijay Singh-- were arrested for the alleged theft under Sections of the BNS.

2,000 HOPEFULS FOR 120 SEATS

In Surat, BJP faces ‘problem of plenty’; 15 couples also in fray

EVEN AS the ruling BJP has taken up an exercise to screen its prospective candidates for the municipal polls in Surat on April 26, there are at least 15 party workers in the city who have filled two forms—one for themselves and another for their spouse, party officials said.

Until Friday, more than 2,000 people had wished to contest the 120 seats in the municipal corporation, meaning there were at least 50 takers for every three seats.

Hinting that there might be 'problems' after the selections are made, a senior party leader said on the condition of anonymity: "This time, a record-breaking number of party workers are seeking tickets in the SMC (Surat Municipal Corporation) elections."

SMC has 30 wards, each of which has four seats. While the Bharatiya Janata Party (BJP) won 93 of them in the 2021 elections, the remaining 27 were taken by the Aam Aadmi Party (AAP), making Surat the only civic body in Gujarat where all opposition seats were won by the latter that year.

Later, 14 AAP corporators defected to the BJP, and one

was suspended, leaving just 13 corporators in the AAP's fold till the House's dissolution.

Meanwhile, the BJP's state unit has deployed 12 observers to collect proposal forms of candidates who wish to contest.

Sources in the party's Surat unit said the couples who wished to contest were Gauriben Sapariya, who represented ward no. 9, and Magan Sapariya, Ashit Gandhi and Rajeshwari, Khimji Rathod and Jasuben Rathod, Nilesh Tank and Hina Tank, Hiren Vanwala and Darshana, Krishna Patel and Meeta, Mayur Rangani and Maya, Amarsinh Tank and Manjula, Babu Jagjivan Patel and Ushaben Patel, and Khimji Sohan Patel and Jasuben Patel.

Gauriben spoke to this reporter: "My husband and I have filled the proposal form and

submitted it to the election observers to contest the election from Ward no. 9. My husband has spent 35 years in the BJP, but he did not hold any post nor has he contested any election. During my tenure [as a corporator], I worked on public issues and got the SMC staffers to resolve them. In the last five years, not a single allegation has been made against my husband or me."

A senior leader from Surat BJP said, "The decision (on who will be chosen) will be taken by the [party's] state parliamentary body. The election observers have collected proposal forms from them."

The party sources added that the observers had collected 800 forms of candidates on Wednesday, 750 on Thursday, and 500 on Friday.

Two kids of a family die after eating dosa; Ahmedabad dairy under lens

A DAIRY in Chandkheda in Ahmedabad is now under the scanner of the city police, Food and Drugs Control Administration (FDCA) and Ahmedabad Municipal Corporation (AMC) after two daughters of a family, aged two and a half months and three years, died on Saturday and Sunday, allegedly due to severe food poisoning.

The children fell sick after consuming 'dosa' made from the readymade batter bought from the dairy on IOCL Road in Chandkheda.

Speaking to reporters on Monday, Inspector (Chandkheda police) JK Makwana said, "On April 5, one Vipulkumar Gaurishankar Prajapati informed the police that his three-year-old daughter Mishiti died a day after his younger daughter, aged two and a half months, on April 4. We have filed an accidental death (AD) report and have begun an investi-

gation in this case."

Inspector Makwana said: "Prajapati told the police that on April 1, he bought dosa batter from Ghanshyam Dairy on IOCL Road in Chandkheda. The family made dosa from this batter and consumed them on April 1 and 2. They all became sick but got better after the initial treatment. So, they didn't seek further medical investigation."

He added: "However, their condition worsened again and their infant daughter died on April 4. They performed the child's last rites without informing any official. The next day, their three-year-old daughter fell unconscious, and was admitted to KD Hospital, where she died on April 5. Prajapati then informed the police about her death."
