Subject: Update on Legal Proceedings

Dear Sir/Madam,

This is with reference to the captioned subject, please find below the update on legal proceedings of the Company for your information and records.

Please note that, Hon'ble High Court of Delhi, at New Delhi vide order dated 18.03.2025 in W.P. (CRL) 16221/2019 & CrI.M.A. 29934/2024 filed for quashing of RCDAl-2019-A-0003, under section 120B of IPC read with section 419/420/468/471 IPC registered by CBI against the Petitioner through its Managing Director.

Ld. Special Public Prosecutor for CBI submitted that, Charge-Sheet has already been filed, in which admittedly the petitioner (i.e., the Company) is not named. Further, in the Charge-Sheet, the Company has been named as Prosecution Witness No. 6. Taking into consideration of the developments, Hon'ble High Court of Delhi ordered that, "... **nothing survives for consideration in the present petition and it is hereby disposed of.**"

Further, Hon'ble High Court of Delhi also ordered, **pending application is disposed of as infructuous.**
