सर्वोच्च न्यायालयाचे माजी न्यायमूर्ती पी. बी. सावंत यांचं निधन

पुणे, दि. १५ (हिंदुस्थान समाचार): सर्वोच्च न्यायालयाचे माजी न्यायमूर्ती पी. बी. सावंत यांचं आज वृद्धापकाळानं निधन झालं. ते ९१ वर्षाचे होते. पुण्यातील राहत्या घरी सकाळी साडेअठ्ठा वाजण्याच्या सुमारास त्यांनी अखेरचा श्वास घेतला. पुण्यातील बाणेरम ध्ये उठा सकाळी त्यांच्या पार्श्र्वावर अंत्यसंस्कार होणार आहेत.

अतिशय कडक शिस्तीचे न्यायमूर्ती अशी सावंत यांची ओळख होती. त्यांच्या कार्याकाळात अनेक महत्त्वपूर्ण खटल्यांचा निकाल लागला. मुंबई विद्यापीठातून कायद्याची पदवी (एलएलबी) मिळवल्यानंतर सावंत यांनी मुंबई उच्च न्यायालयात आणि नंतर सर्वोच्च न्यायालयात वकिली केली. १९७३ मध्ये त्यांची मुंबई उच्च न्यायालयाचे न्यायाधीश म्हणून नियुक्ती झाली. १९८९ मध्ये त्यांची सर्वोच्च न्यायालयात नियुक्त करण्यात आली. तिथून १९९५ मध्ये ते निवृत्त झाले. निवृत्तीनंतर ते सामाजिक कार्यात सक्रिय होते. पुण्यातील पहिली एल्गार परिषद पी. बी. सावंत यांच्या नेतृत्वाखालीच पार पडली होती.

काँग्रेस-राष्ट्रवादी आघाडी सरकारमधील मंत्र्यांवर झालेल्या भ्रष्टाचाराच्या आरोपांची चौकशी करण्यासाठी स्थापन केलेल्या आयोगाचे पी. बी. सावंत यांच्याकडे होते. २००९ साली त्यांच्या या प्रकरणाचा अहवाल सादर केला. त्यात नवाब मलिक, पद्मसिंह पाटील आणि सुरेश जैन यांच्यावर ठपका ठेवण्यात आला होता. या अहवालानंतर सुरेश जैन आणि नवाब मलिक यांना मंत्रिपदाचा राजीनामा द्यावा लागला होता.

‘पी. बी. सावंत यांच्या निधनाने एक उत्तम कायदेतज्ज्ञ आपल्यातून निघून गेले आहेत. त्यांच्या निधनामुळे राज्यातील पुरोगामी चळवळीचं मोठं नुकसान झालं आहे. राज्यघटनेची मूल्ये आणि सामाजिक समतेसाठी त्यांनी आपलं संपूर्ण जीवन समर्पित केलं होतं.

Impeachment isn't the final word on Capitol riot for Donald Trump

He is stripped of his protection from legal liability that the presidency gave him

DONALD TRUMP'S ACQUITTAL at his second impeachment trial may not be the final word on whether he's to blame for the deadly Capitol riot. The next step for the former president could be the courts.

Now a private citizen, Trump is stripped of his protection from legal liability that the presidency gave him.

That change in status is something that even Republicans who voted on Saturday to acquit of inciting the January 6 attack are stressing as they urge Americans to move on from impeachment.

"President Trump is still liable for everything he did while he was in office, as an ordinary citizen, unless the statute of limitations has run," Senate Minority Leader Mitch McConnell of Kentucky said after that vote. He insisted that

the courts were a more appropriate venue to hold Trump accountable than a Senate trial. "He didn't get away with anything yet," McConnell said. "Yet."

The insurrection at the Capitol, in which five people died, is just one of the legal cases shadowing Trump in the months after he was voted out of office.

He also faces legal exposure in Georgia over an alleged pressure campaign on state election officials, and in Manhattan over hush-money payments and business deals.

But Trump's culpability under the law for inciting the riot is by no means clear-cut. The standard is high under court decisions reaching back 50 years. Trump could also be sued by victims, though he has some constitutional protections, including if he acted while carrying out the duties of president. Those cases would come down to his intent.

Legal scholars say a proper criminal investigation takes time, and there are at least five years on the statute of limitations to bring a federal case.

New evidence is emerging every day.

"They're way too early in their investigation to know," said Laurie Levenson, a law professor at Loyola Law School and former federal prosecutor.

"The have arrested 200 people, they're pursuing hundreds more, all of those people could be potential witnesses because some have said Trump made me do it."

What's not known, she said, is what Trump was doing during the time of the riot, and

that could be the key. Impeachment didn't produce many answers. But federal investigators in a criminal inquiry have much more power to compel evidence through grand jury subpoenas.

"It's not an easy case, but that's only because what we know now, and that can change," Levenson said.

The legal issue is whether Trump or any of the speakers at the rally near the White House that preceded the assault on the Capitol incited vi-

Covid's puzzling decline in India sparks a shopping spree

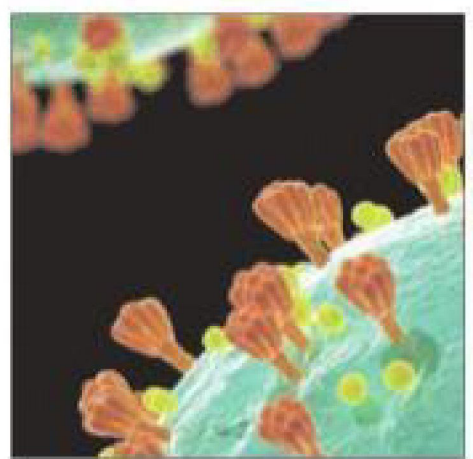
FOR THE HOME to the world's second-largest Covid-19 outbreak, life in India is almost back to normal.

Shopping mall parking lots are full again. Stores are buzzing, and there are long lines for hair salons and restaurants.

"We just got fed up sitting at home, for how long can you do that?" said Kaniz Zehra, a 32-year-old stay-at-home parent to a toddler and a 5-year-old. In recent months, she's flown for two domestic holidays; last month, she braved the crowds at the DLF Mall of India, one of the country's largest, outside of New Delhi.

"Initially there was a fear of getting the infection," she said. "But now it appears it hasn't affected Indians as badly as it hit people in other countries."

While the US and large swaths of Europe remain in crisis and China stays vigilant



fallen by a similar rate, from more than 1,000 a day in September to fewer than 100 now.

Epidemiologists have questioned those numbers, pointing to low rates of testing and habitual underreporting of causes of death, particularly in rural India. But even if the numbers are artificially low, a lull in the country's Covid wards suggests the trend is real.

The steady decline of reported Covid infections in India has puzzled scientists, especially given that many countries are battling second, third and fourth waves. Since daily cases peaked close to 100,000 in September, new transmissions have dropped nearly 90%. Deaths have

Iran says US move to seize oil shipment is 'act of piracy'

IRAN SAID ON Monday that a US move this month to seize a cargo of oil on the grounds that it came from Tehran was an act of piracy, adding that the shipment did not belong to the Iranian government.

Washington filed a lawsuit earlier this month to seize the cargo, alleging that Iran sought to mask the origin of the oil by transferring it to several vessels before it ended up aboard the Liberian-flagged Achilles tanker destined for China.

Tensions have mounted between Washington and Tehran since 2018, when former US President Donald Trump abandoned Iran's 2015 nuclear deal

Washington said the cargo contravened US terrorism regulations.

"This shipment does not belong to the Iranian government. It belongs to the private sector," Foreign Ministry spokesman Saeed Khatibzadeh told a weekly news conference. He did not elaborate on what he meant by the private sector. The Achilles last reported its position on Sunday as anchored within the Galveston Offshore Lightering Area, which is outside the US Gulf port of Galveston, Refinitiv ship tracking data showed on Monday.
