In case of 9,00,000 Equity Shares of Kore Foods Limited held by Polaroid Corporation (hereinafter referred to as "Polaroid") who belong to promoter group, we inform that Polaroid has been in bankruptcy proceedings under US Court appointed Trustee – Mr. John Stoeber of Lapp, Libra, Stoeber & Pusch Chartered, a firm of attorneys in the US. The said trustee has decided that the shares held by Polaroid have no recoverable value and asked the court permission for abandonment of said shares. Accordingly the US District Court of Minnesota under the Judge Kathleen H. Sanberg has passed the order granting the same. Accordingly we do not know the status of the shares held by Polaroid. As per records of Kore Foods Limited Polaroid continues to be a shareholder holding 9,00,000 Equity Shares. Hence we are giving this disclosure.
