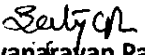

DGP: Drunken drivers causing death to be tried under attempt to suicide

Bhopal: To check deaths caused by drunken drivers, instructions have been given by DGP Rishi Shukla to register case of attempt to suicide against such drivers.

The instructions were given in compliance with the instructions given by Chief Minister Kamal Nath for deaths due to drunken drivers in the state. If someone dies in a road accident due to vehicles driven by drunken driver then a case of Punishment for culpable homicide not amounting to murder which is section 304 of IPC and would be non-bail able. After

the approval of DGP Singh, Special Director General PTRI Purushottam Sharma has issued clear instructions in this regard through a circular to all the Superintendents of Police, including the Deputy Inspectors General of Bhopal and Indore. Apart from this, the Director General of Police of all the ranges has been instructed to follow these instructions. Special DG Sharma said that all the superintendents of police have been directed to conduct medical examination of the driver if there is a road accident and IO has to submit the dri-

ver's medical report with the case diary and has to make it check amount of alcohol in the driver's body as per report and was the influence of alcohol responsible for the accident death.

Special DG Sharma said that in accordance with the directives of the Road Safety Committee of the Supreme Court a target of reducing the accidents by 10 per cent has been set for this year. Special campaign would be organised in the month of June to check drunken driver in the month of June. **SR**

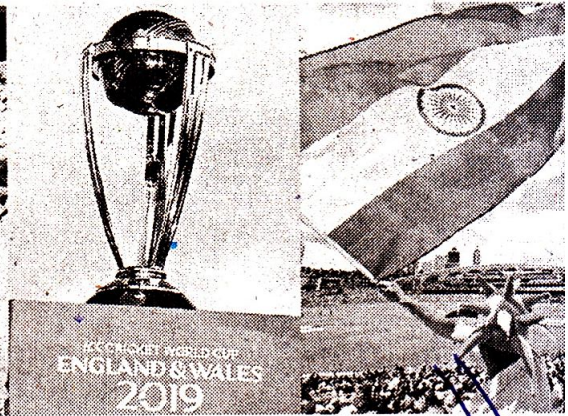

वेस्टइंडीज ने 421 रन बनाकर दिए संकेत

दक्षिण अफ्रीका का वेस्ट इंडीज के साथ पहला अभ्यास मैच बारिश के कारण रद्द रहा था लेकिन दक्षिण अफ्रीका ने दूसरे अभ्यास मैच में श्रीलंका को 87 रन के बड़े अंतर से पराजित किया था। वेस्ट इंडीज ने अपने दूसरे मैच में शानदार वापसी करते हुए न्यूजीलैंड के खिलाफ 421 रन का विशाल स्कोर बनाकर 91 रन से एकतरफा जीत हासिल की थी। न्यूजीलैंड ने इस

मुकाबले में सराहनीय संघर्ष करते हुए 330 का स्कोर बनाया। दूसरी ओर दक्षिण अफ्रीकी टीम के कप्तान फाफ डू प्लेसिस अपना तीसरा विश्वकप खेलने उतर रहे हैं और टीम के सबसे निरंतर खिलाड़ियों में शामिल हैं। अपने आखिरी 2015 विश्वकप में उन्होंने

आयरलैंड के खिलाफ 109 रन की अपनी सर्वश्रेष्ठ पारी खेली थी जबकि अब तक तीन विश्वकप के 14 मैचों में उन्होंने 539 रन बनाये हैं, इसी प्रदर्शन की इस बार भी अपेक्षा उनसे है। प्लेसिस ने श्रीलंका के खिलाफ अभ्यास मैच में भी 88 रन की कमाल की पारी खेली थी।
