Proceedings of 24th Annual General Meeting of M/s. Impex Ferro Tech Limited

2. The Chairman of the Meeting Mr. Suresh Kumar Patni was unable to attend the meeting due to some important business conference, hence in his absence Mr. Ankit Patni took the chair after approval from shareholders. Mr. Sharat Malik and Mrs. Sujata Agarwal was also not present in the meeting as they are out of town.

The Company Secretary, Chief Financial Officer, representative of Statutory Auditors and Secretarial Auditor were also present.

3. Total 68 members including proxies and authorised representative of Companies attended the AGM as per record.
4. The Chairman welcomed the members at AGM and informed that requisite quorum was present and called the meeting to order.
5. The Chairman then introduced all the directors present on the dais.
6. With consent of the members, the Notice convening the 24th AGM including explanatory statements under Section 102 of the Companies Act, 2013 was taken as read.

The Chairman informed the members present that the Register of Directors and Key Managerial Personnel and their Shareholdings and other statutory registers/records were available at the meeting venue and the same would remain open and accessible during the continuance of the meeting to the shareholders.
8. Mr. Ankit Patni, Chairman thereafter delivered the speech in which he gave an overview of the business along with its optimism of future progress and financial performance of the Company for the year ended 31st March, 2019.

9. The Chairman read out the observations and remarks raised in Statutory Auditors report and Secretarial Auditors report and also the replies of the same from the Management of the Company.
