Kshitij Investment Limited

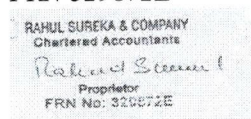
1. We have reviewed the accompanying statement of unaudited financial results of M/s Kshitij Investment Limited. We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India.
