The Board of Directors appointed Mr. Parag Dasarwar, Practicing Company Secretary as the Scrutinizer to supervise the e-voting process.

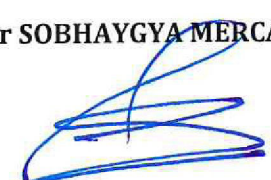
The Company Secretary, thereafter, informed the members that the meeting was concluded.
