We hereby inform you that with reference to the captioned subject, pursuant to regulation 30 read with para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") the shareholders of the Company at the Extra Ordinary General Meeting held on Wednesday, January 14, 2026, has approved following amendment in the Memorandum of Association of the Company;

AMENDMENT IN THE OBJECT CLAUSE

Subject to the approval of the concerned Registrar of Companies Ministry of Corporate Affairs, following sub clauses has been inserted in substitution of sub clause (1) of clause III (A) of the Memorandum of Association of Company:

- 1. To carry on the business of manufacturing, distilling, brewing, fermenting, bottling, blending, processing, packaging, marketing, trading, importing, exporting, and dealing in all kinds of alcoholic and non-alcoholic beverages including but not limited to spirits, wines, liquors, beers, ciders, cocktails, mocktails, mineral water, aerated drinks, juices, energy drinks, and other potable liquids, whether carbonated or non-carbonated, flavoured or unflavoured, and to establish, acquire, operate and manage breweries, distilleries, wineries, bottling plants, blending units, cold storage facilities, and allied infrastructure for the same and to undertake the business of research, development, and innovation in beverage formulations, flavour enhancement, preservation techniques, and sustainable packaging solutions, and to acquire, license, or develop intellectual property, trademarks, and proprietary technologies related thereto.*
- 2. To carry on the business of hospitality, retail, and distribution including setting up of bars, lounges, tasting rooms, retail outlets, and e-commerce platforms for the sale and promotion of the Company's products, subject to applicable laws and regulatory approvals.*
