Unsettled by the American election drama, markets look on bright side

Global stocks have resumed their march higher

London, November 5

THOSE WHO BANKED on a big US government spending splurge may be dismayed but two days on from US Election Day, investors are looking on the bright side - less regulatory tightening than feared and a central bank still in full money-printing mode.

Global stocks have resumed their march higher even as Democratic challenger Joe Biden edged closer to

snatching the presidency from Donald Trump, and there is little sign of panic about an election outcome that may end up in the courts.

Disappointment over stimulus appears to have been replaced by relief that without a Biden clean sweep of Congress and the White House, gridlock between a Biden administration and a potentially Republican Senate would scupper any plans to tighten the screws on tech and pharma giants.

Bets on those sectors gathered momentum, even as shares in renewables - where Biden has pledged large investment - rallied on an assumption that climate-friendly assets will emerge winners no matter who the



next president is.

"Less regulation...is a huge positive and offsets the probability of reduced stimulus," said Justin Onuekwusi, portfolio manager at Legal & General Investment Management.

"You go back into the medium-term scenario of reflation as well as the lower-for-

longer scenario," he said, referring to expectations of rock-bottom borrowing costs alongside a smaller fiscal spending package.

The market gyrations of the past 36 hours represent some position unwinding, given the tighter-than-expected race, investors said, but

with the US and global backdrop one of abundant liquidity and rock-bottom bond yields, flows into equities and company debt are likely to continue.

That is especially so for the mega-tech firms - shares in Apple, Amazon and Alphabet are building on Wednesday's rally.

For Jonathan Bell, chief investment officer at Stanhope Capital, the outcome was the best of both worlds.

"Biden being elected increases the chances of a fiscal stimulus deal, but (with a Republican Senate) it also reduces the ability for him to push through significant taxes rise or policies that might constrain the likes of Amazon and Apple," Bell said.

Over dozen Indian-Americans win state polls; another 4 re-elected

MORE THAN A dozen Indian-Americans, including five women, have won state-level elections, marking a first for the community in many instances.

This is in addition to the four Indian-Americans elected to the US House of Representatives: Ami Bera, Pramila Jayapal, Ro Khanna and Raja Krishnamoorthi. At least three other races, including one for the US House of Representatives, are yet undecided.

The five women elected to state legislatures are Jennifer Rajkumar to the New York State Assembly, Nima Kulkarni to the Kentucky State House, Keshia Ram to the Vermont State Senate, Vandana Slatter to the Washington State House and Padma Kuppa to the Michigan State House.



Niraj Antani has been declared elected to the Ohio State Senate, while Jay Chaudhuri has been re-elected to the North Carolina State Senate. Amish Shah has been elected to the Arizona State House, Nikil Saval to the Pennsylvania State Senate, Ranjeev Puri to the Michigan State House and Jeremy Cooney to the New York State Senate. Ash Kalra has been re-elected to the California State Assembly for the third consecutive term. Ravi Sandhill has won the District Court Judge polls in Texas.

Keshia Ram is the first woman of colour elected to the Vermont State Senate, Nikil

Saval is the first Indian-American elected to the Pennsylvania General Assembly, Jennifer Rajkumar is the first South Asian woman elected to the New York state office and Niraj Antani is the first Indian-American elected to the Ohio Senate.

"This year's election represented a giant leap forward for the Indian-Americans' role in US politics," said Neil Makhija from the Impact Funds, which had raised a whopping \$10 million during this election cycle and endorsed a large number of Indian-American candidates.

"Indian-American voters and candidates demonstrated the burgeoning power and influence of this important voting bloc in decisive fashion, which will help make the difference in key states like Michigan and Pennsylvania," he added.
