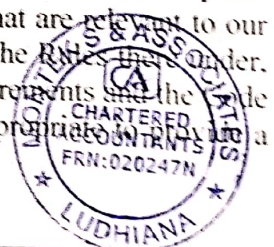

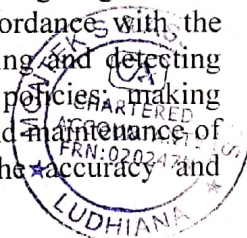
Emphasis of Matter Paragraph

We draw attention to the below mentioned facts on which our opinion is not modified

- i) We draw attention to Note no 8 to the financial statements, which states that the closing inventory as at March 31, 2025 is based on a stock statement certified by the management, and no physical verification of inventory was conducted by the Company during the year.
- ii) The Company has not obtained balance confirmations from certain trade receivables (debtors) and trade payables (creditors) as at March 31, 2025.
- iii) The Company has entered into significant transactions during the year with its sister concerns. These transactions constitute a substantial portion of the Company's operations
- iv) We draw attention to Note no 1 to the financial statements, which states that the Company has shown land and building valued at Rs. 148.06 lakhs, for which full consideration has been paid and possession was taken on January 20, 2014. However, the transfer deed for the said asset has not been executed till date, and accordingly, the title deed is not in the name of the Company. Our opinion is not modified in respect of this matter.
- v) The Company has not recognized the Right-of-Use (ROU) assets and corresponding Lease Liabilities as required by Indian Accounting Standard (Ind AS) 116, *Leases*, in respect of certain lease arrangements. In our view, this accounting treatment is not in compliance with Ind AS 116, which requires lessees to recognize ROU assets and lease liabilities for all leases, subject to specified exemptions.

Management's Responsibilities for the Standalone Financial Results

These quarterly financial results as well as the year-to-date standalone financial results have been prepared on the basis of the interim financial statements. The Company's Board of Directors are responsible for the preparation of these financial results that give a true and fair view of the net profit/loss and other comprehensive income and other financial information in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, 'Interim Financial Reporting' prescribed under Section 133 of the Act read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls that were operating effectively for ensuring the accuracy and

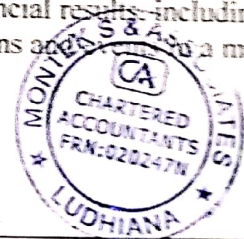

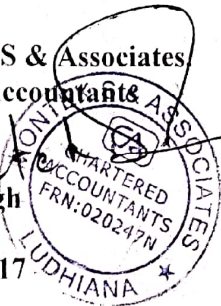

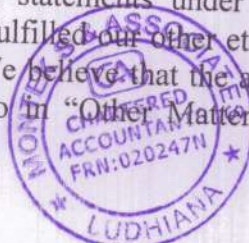

Emphasis of Matter Paragraph

We draw attention to the below mentioned facts on which our opinion is not modified

- i) We draw attention to Note no 8 to the financial statements, which states that the closing inventory as at March 31, 2025 is based on a stock statement certified by the management, and no physical verification of inventory was conducted by us during the year.
- ii) The Company has not obtained balance confirmations from certain trade receivables (debtors) and trade payables (creditors) as at March 31, 2025.
- iii) The Company has entered into significant transactions during the year with its Related Parties. These transactions constitute a substantial portion of the Company's operations
- iv) We draw attention to Note no 1 to the financial statements, which states that the Company has shown land and building valued at Rs. 148.06 lakhs, for which full consideration has been paid and possession was taken on January 20, 2014. However, the transfer deed for the said asset has not been executed till date, and accordingly, the title deed is not in the name of the Company. Our opinion is not modified in respect of this matter.
- v) The Company has not recognized the Right-of-Use (ROU) assets and corresponding Lease Liabilities as required by Indian Accounting Standard (Ind AS) 116, *Leases*, in respect of certain lease arrangements. In our view, this accounting treatment is not in compliance with Ind AS 116, which requires lessees to recognize ROU assets and lease liabilities for all leases, subject to specified exemptions.
