Declaration of results of Postal Ballot and E-voting

Pursuant to Section 192A of the Companies Act, 1956 read with the Companies (Passing of the Resolution by Postal Ballot) Rules, 2011, as amended from time to time, (the "Postal Ballot Rules"), read with SEBI Circular No. CIR/CFD/DIL/5/2013 dated February 4, 2013 and No. CIR/CFD/DIL/8/2013 dated May 21, 2013 (together known as "the SEBI Circulars") and as directed by the Hon'ble High Court of Gujarat at Ahmedabad in the Company Application No. 252 of 2013 vide its interim order dated October 14, 2013, the approval of Equity shareholders of D. B. Corp Limited ("the Company") was sought through postal ballot and e-voting for the amendment of the Objects clause of the Memorandum of Association of the Company and for approval of the Scheme of Arrangement ("Scheme") in the nature of demerger of Integrated Internet and Mobile Interactive Service Business of I Media Corp Limited to D. B. Corp Limited.

Accordingly, the Company made necessary arrangements for conducting postal ballot and e-voting. The Company appointed Mr. S. Anand SS Rao, Practising Company Secretary, Hyderabad as Scrutinizer for conducting the Postal Ballot and e-voting process in a fair and transparent manner. Further, the Company engaged Karvy Computershare Pvt. Ltd., Hyderabad ("Karvy") to provide e-voting facility to the Equity shareholders of the Company.

After completion of the scrutiny of the Ballot papers received and votes cast through e-voting, the Scrutinizer Mr S. Anand SS Rao has submitted his report dt. 13th December, 2013.

Pursuant to receipt of the Scrutinizer's report, the results of the postal ballot and e-voting are hereby declared today i.e. on December 14, 2013 at 6:00 pm at the Registered office of the Company.
