The requisite quorum being present, the meeting was called in order and open at 11.43 a.m. IST.

Mrs. Arti Nishant Jain, informed to the members that the meeting was conducted through VC /OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India. She also gave general instructions regarding participation in the meeting.

2. To appoint a Director in place of Mrs. Payal Ankur Bankda (DIN: 09483787), who retires by rotation in terms of section 152(6) of the Companies Act, 2013 and being eligible offers herself for re-appointment. (Ordinary Resolution)
3. To appoint M/s. Madhuri J. Bohra & Associates (Membership No A54739 / COP No. 20329), Practicing Company Secretary, Mumbai as Secretarial Auditors of the Company for a term of 5 years. (Ordinary Resolution)
