In terms of Regulation 30 read with Schedule III and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, 'SEBI (LODR) Regulations', we hereby give a reminder in continuation of our previous disclosure dated July 22, 2025 and the above referred SEBI Circular, the Shareholders are once again hereby informed that a Special Window has been opened only for re-lodgement of transfer deeds, which were lodged prior to the deadline of April 1, 2019 and rejected/returned / not attended due to deficiency in the documents/process or otherwise.
