Pursuant to Regulation 30 read with Schedule III and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation of our final newspaper publication reminder dated November 22, 2025, and the captioned SEBI Circular, we hereby inform the shareholders that the **Special Window opened exclusively for re-lodgement of transfer deeds of physical shares has now been closed.**

The said Special Window was applicable to transfer deeds pertaining to physical shares that were originally lodged **prior to April 1, 2019** and were rejected, returned, or not processed due to deficiencies in documents, procedures, or for any other reason. The re-lodgement window was open for a period of six (6) months, i.e., from July 7, 2025, to January 6, 2026.

Accordingly, the Special Window for re-lodgement of transfer requests of physical shares stands closed. Shareholders are requested to take note of the same.
