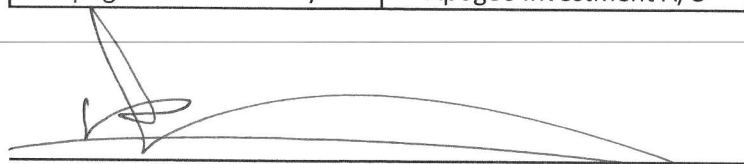

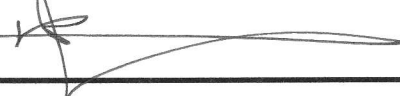

**DIRECTIONS**
