

## ASX Announcement:

# Update on Sale of 5GN Business and Proposed Capital Return



21<sup>st</sup> August 2024

5G Networks Limited (**5GN**) announced on 27 June 2024 that its wholly owned subsidiary 5G Networks Holdings Pty Ltd (**5GN Holdings**), had entered into sale agreements with entities associated with Mr Joe Demase (**Purchasers**) in relation to the sale of 100% of the shares in its primary operating subsidiary, 5G Network Operations Pty Ltd (**5GN Operations**) and its cyber security consultancy business operated by Security Shift Pty Ltd (**Security Shift**).

In the announcement of 27 June, 5GN stated that it expected the Notice of Meeting (**NOM**) and Explanatory Booklet would be sent to 5GN shareholders during August 2024. 5GN wishes to update the market that it now expects the NOM and Explanatory Booklet will be sent to 5GN shareholders in September 2024. The NOM and Explanatory Booklet will provide additional information relating to the transaction, the reasons for the Independent Directors' recommendation, information relating to the proposed Capital Return and the delisting and an Independent Expert's Report opining on whether the transaction is fair and reasonable to non-associated 5GN shareholders.

The EGM to approve the transaction is anticipated to be held in October 2024 and, if approved by shareholders, completion of the transaction and the Capital Return is expected to occur shortly following the EGM. The delisting of 5GN is expected to occur following completion of these transactions, subject to complying with any requirements of ASX. 5GN is expected to be wound up in 2025.

This announcement has been authorized by 5GN's Independent Board Committee.
