- b) The Company issued shares to sophisticated investors as it was considered to be a more efficient mechanism for raising the funds for this Placement. The Placement did not expose the Company to the market volatility that it may have experienced over a more extended capital raising process such as a pro-rata issue;
- c) No underwriting arrangements were in place for the Placement; and
- d) The Company will pay a commission of 6% on the amount raised in the Placement.
