

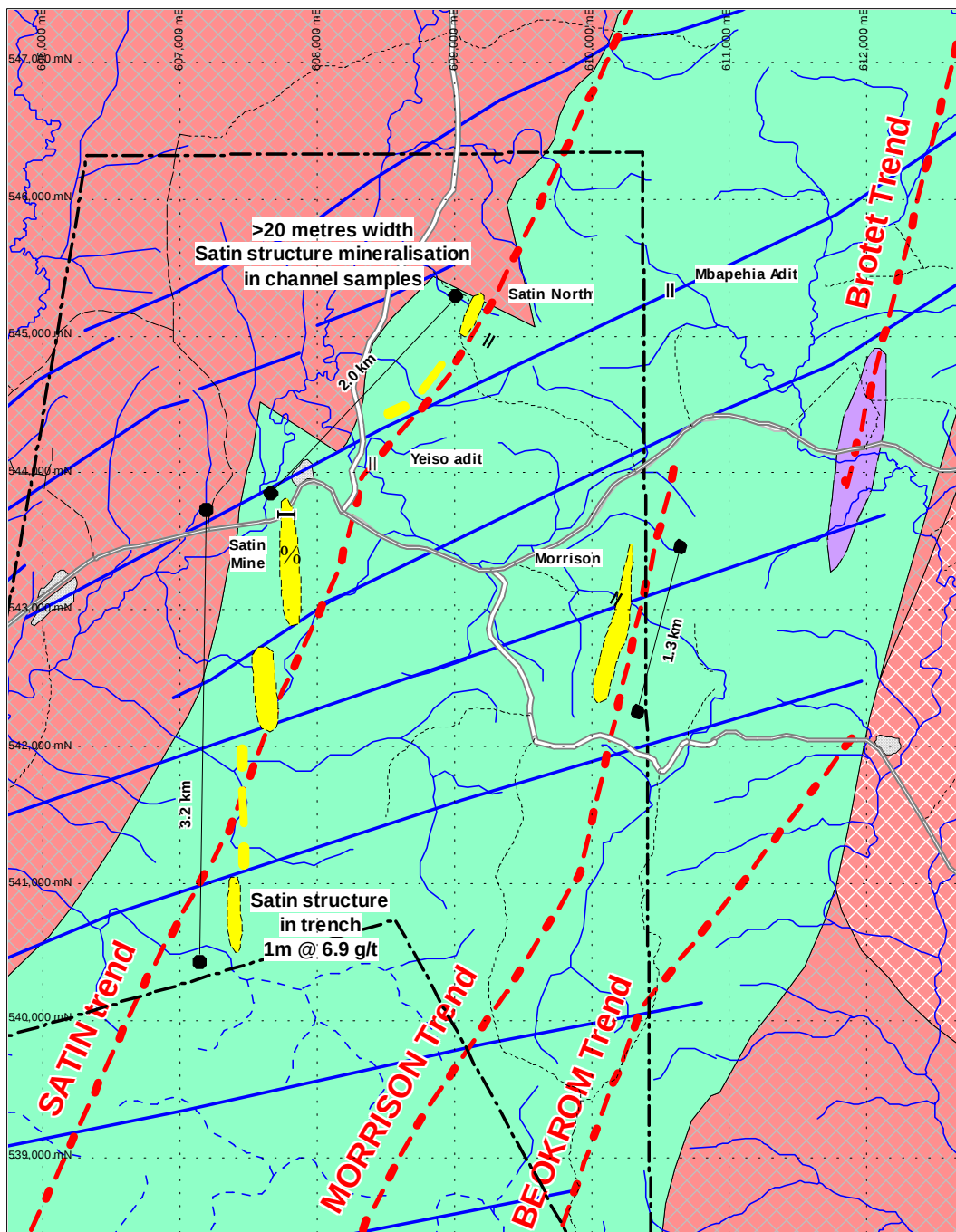


NMG DRILLING CONTINUES AT CAPE THREE POINTS LICENCE IN GHANA

ANNOUNCEMENT

Noble Mineral Resources Ltd (ASX: NMG) is pleased to announce that an MPD 1000 RC drill rig arrived at the Cape Three Points Prospecting Licence in Ghana on Tuesday, 17 November 2009.

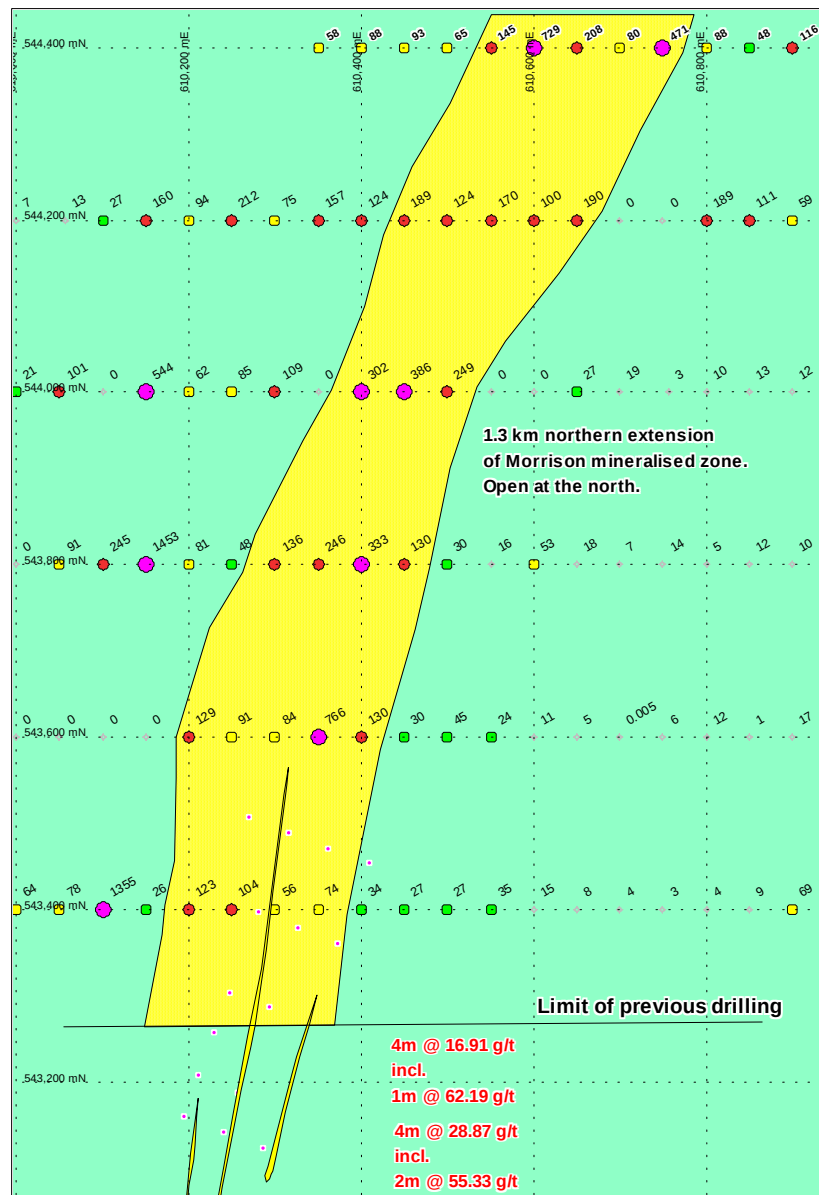


A shallow programme of approximately 3,000 metres of RC drilling will focus upon the definition of along strike extensions of the high grade gold mineralisation identified on the Morrison Prospect earlier this year. In September this year Noble announced significant drill intersections at the northern end of the Morrison Prospect including **4m @16.91 g/t**.

Other targets to be tested are the Satin North prospect which lies two kilometres north of the historic, high grade, Satin underground mine.

The same structure has also been identified in trenches 3.2 kilometres south of the Satin Mine. RC drilling of these trenches commenced last week.

A soil sampling programme has been completed over the adjoining Brotet Prospecting Licence. These soils have extended the Morrison mineralised trend for a further 1.3 kilometres north east of current drilling. This soil anomaly remains open to the north.

Competent Person's Statement

About Noble Mineral Resources Limited

Noble Mineral Resources Ltd ("Noble") is focussed on exploring for large-scale gold deposits in the world-class Ashanti Gold Belt in Ghana. Noble listed on the Australian Securities Exchange on 26 June 2008.

Noble's primary gold concessions are two Exploration Licences, **Cape Three Points** and **Tumentu**, which cover some 88km² and are located within the world-class Ashanti Gold Belt in south eastern Ghana. Ghana is the second largest gold producer in the African continent and is the 10th largest gold producing nation in the world, with annual production of approximately 2.4 million ounces.

Noble's current focus is evaluating the Cape Three Points Concession within the southern extension of the Ashanti Gold Belt. Initial exploration is targeting the **Satin Mine Prospect** and the **Morrison Prospect**, which both lie in an area of historic underground gold production. Noble believes that there is significant potential for the delineation of additional high-grade gold mineralisation relating to the down-plunge extension to these zones.

As well as these more advanced exploration opportunities, the Cape Three Points concession hosts three other project areas for immediate follow-up and five lower-priority prospect areas that Noble has earmarked for ongoing exploration.

The Tumentu Concession is located along strike between the Prestea gold mine and the 1.6 million ounce Salman-Anwia gold deposit currently being explored by ASX-listed Adamus Resources Limited. Artisanal mining, soil sampling, mapping and trench sampling, geological mapping and magnetic surveys have been undertaken and indicate anomalous gold levels within the concession.

The Company is applying the latest conceptual geological models and exploration strategies to these relatively under explored, highly prospective prospects, with the aim of rapidly defining a JORC-compliant resource for development.
