

# SECONDARY TRADING NOTICE

Audalia Resources Limited (**Audalia** or the **Company**) (ASX: ACP) advises that it has today issued 2,000,000 fully paid ordinary shares (**Shares**) to Mr Brent Butler, CEO and Executive Director.
