### **Re: Appendix 3B – Issue of Shares to Sulphide Resources Pty Ltd**

3D Resources Limited advises that the agreement with Sulphide Resources Pty Ltd over the Mt Angelo North tenement (M80/247) has received Ministerial Consent and has been finalized. The purchase has involved the total payment of \$25,000 cash plus the issue of 142,857 ordinary shares at \$0.14 cents per share based on the weighted average over 5 business days prior to 1st July 2007. The agreement also involves the payment of a Net Smelter Royalty of 1.5% on any ore processed from the tenement.

These shares are subject to a voluntary escrow period of twelve months or until the release of the next disclosure document whichever is the lesser.
