Share Purchase Plan Shares Issued

AnteoTech Ltd (ASX: ADO) ("AnteoTech" or "the Company") hereby provides notice to the ASX that it has issued 30,768,389 ordinary fully paid shares in the Company ("Shares") pursuant to the Share Purchase Plan ("SPP") per the attached ASX Appendix 2A.

Shares issued from the SPP will be issued under the Company's existing (10%) capacity under ASX Listing Rule 7.1A.

As announced on 20 May 2021, AnteoTech had received applications totalling \$37.1 million and the Board exercised its discretion to increase the SPP from \$4 million to \$8 million. This resulted in \$29.1 million to be returned to shareholders. EFT payments or dispatch of cheques from the scale back have commenced today.
