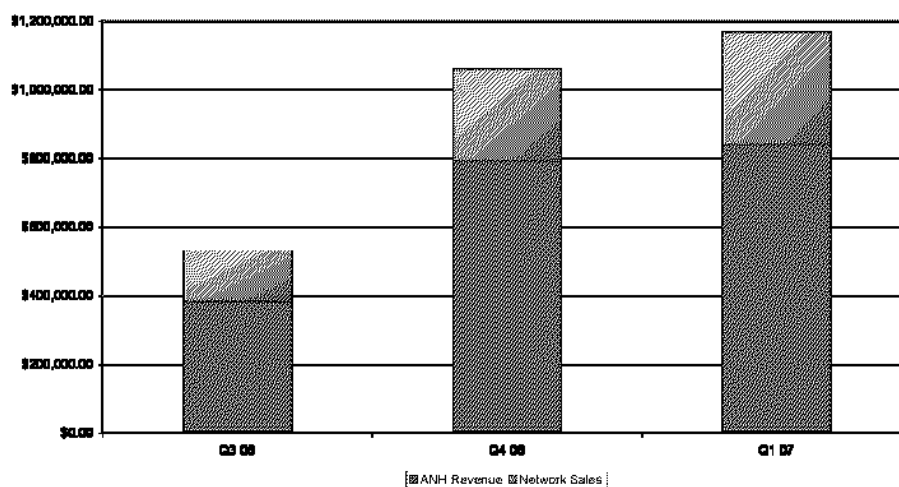
STRONG REVENUE GROWTH CONTINUES FOR ANSEARCH

Ansearch (ASX: ANH) is pleased to report that total online revenue for the September Quarter continued to show a significant upward trend.

Total sales made by Ansearch grew by approximately 10% over the previous quarter with that revenue increasing from \$1.06million to \$1.18million.
