# **QUARTERLY ACTIVITIES REPORT**

**FOR THE QUARTER ENDED 31 MARCH 2022**

## **HIGHLIGHTS**

- North Aubry lithium deposit at Seymour returned thick, maiden GT1 intercept of 40m @ 1.54% Li<sub>2</sub>O.
- North Aubry lithium deposit extended down dip and along strike with further thick, high-grade intercepts.
- Strategic lithium footprint in Ontario expanded from 9,467 Ha to approx. 40,000 Ha.
- Central Aubry and Pye drilling at Seymour commenced with second diamond rig.
- GT1 increases ownership to 80% of the Ontario Lithium Projects.
- Cash balance of A\$16.1M at quarter end; A\$55M equity raising completed in late April.

## ONTARIO LITHIUM PROJECTS: EXPLORATION AND DEVELOPMENT

### Strategic lithium footprint substantially expanded

During the quarter, GT1 significantly increased its landholding in Ontario, Canada. The Company increased its claim base from 9,467 hectares to 39,982 hectares through execution of four option agreements and claim pegging activities. The new landholdings surround GT1's existing projects, Seymour and Root, as well as being in a new project area named "Allison" and select other project areas (Pennock Lake, Root Bay, Superb Lake and Gathering Lake).

For full details of three of the newly acquired claims refer to GT1 ASX release dated 24 January 2022, *Strategic Lithium Footprint Substantially Expanded*. Details of the terms of the Option Agreements are in Appendix C.

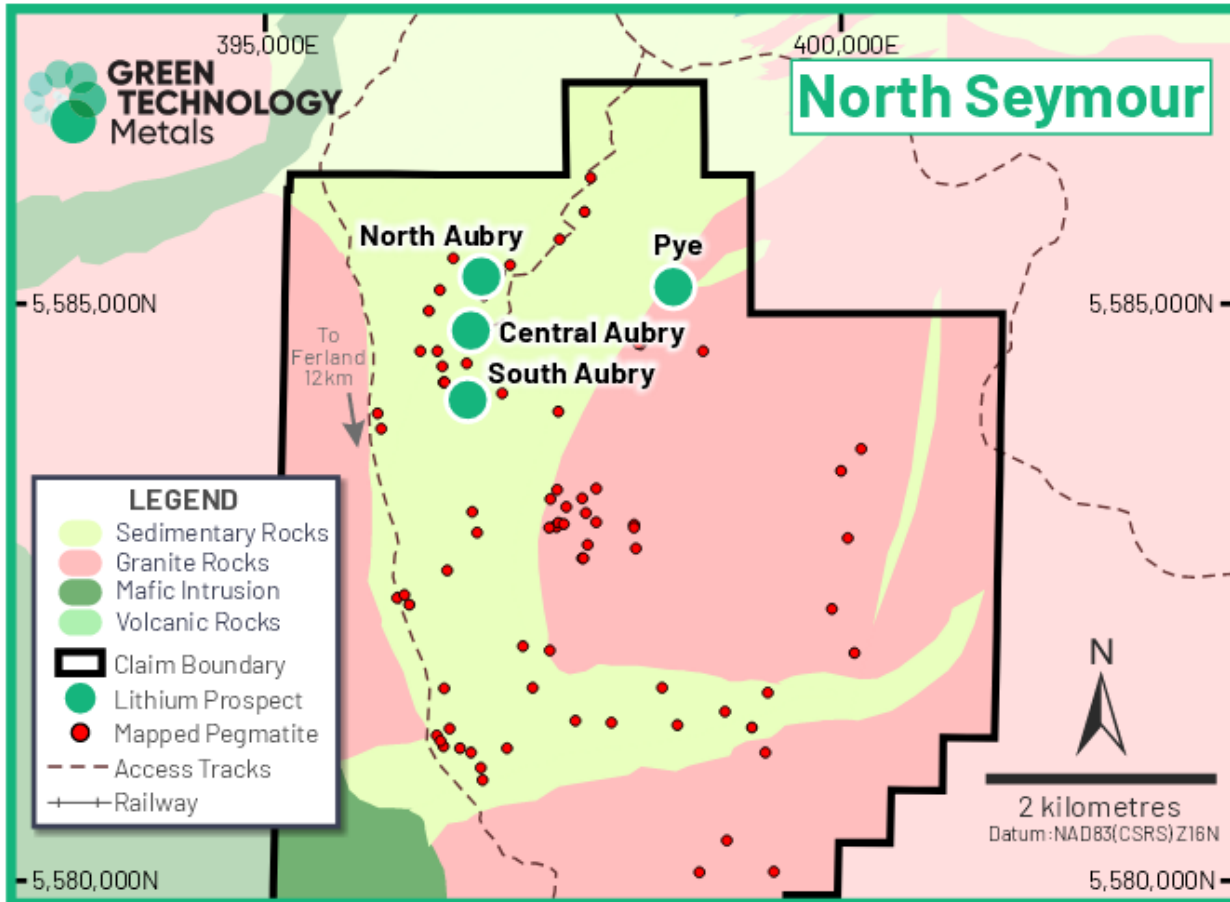
Subsequent to the announcement dated 24 January 2022, the Company executed a further Option Agreement for claims in proximity to Root Bay. For further details, please see the Corporate section of this announcement and Appendix C.

### **Phase 1 diamond drilling program, North Aubry, Seymour.**

The Phase 1 drilling program at North Aubry (Seymour Project) was designed to evaluate potential along-strike and down-dip extensions of the North Aubry deposit that were open and untested. This maiden program is complete with 16 holes having been drilled for a total of 5,826 metres.

All holes in the Phase 1 program intersected pegmatite along strike and down dip (refer GT1 ASX releases dated 8 March 2022 and 17 March 2022). The intercepts returned from solely the upper pegmatite at North Aubry range in thickness up to 42.7m, with the widest intervals located in the northern extensions of the deposit.

Assays have now been returned for 9 of the 16 holes from the Phase 1 program. Results from the first three holes in the program returned key mineralised intervals of 42.7m at 1.54%  $\text{Li}_2\text{O}$  (GTDD-21-0004), 8.9m at 1.46%  $\text{Li}_2\text{O}$  (GTDD-22-0005) and 1.58m at 1.11%  $\text{Li}_2\text{O}$  (GTDD-22-0006) (refer GT1 ASX releases dated 17 January 2022 and 8 March 2022 for full details).

Assay results from the six further holes that were more recently released (refer GT1 ASX release dated 12 April 2022 for full details) are outlined in Table 1 (along with details of the previously released intercepts also). The key intercept from each of these six holes was:

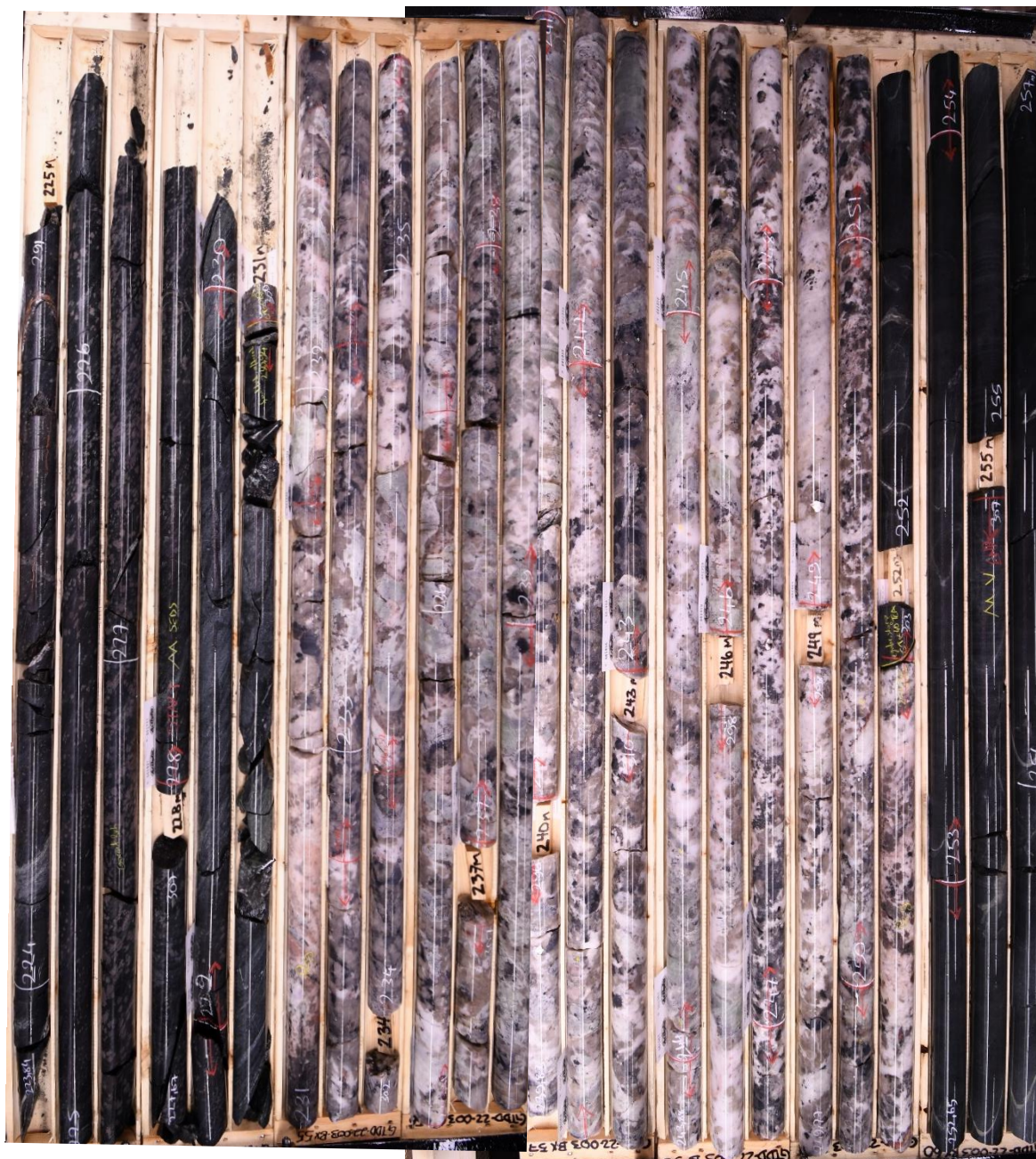
- GTDD-22-0016 for 34.3m @ 1.32%  $\text{Li}_2\text{O}$  from 244.0m
- GTDD-22-0003 for 19.2m @ 2.20%  $\text{Li}_2\text{O}$  from 231.8m (including 9.7m @ 2.95%  $\text{Li}_2\text{O}$ ; see Figure 4 for core photo)
- GTDD-22-0010 for 10.0m @ 1.89%  $\text{Li}_2\text{O}$  from 313.0m (including 5.3m @ 2.85%  $\text{Li}_2\text{O}$ )
- GTDD-22-0015 for 9.0m @ 1.34%  $\text{Li}_2\text{O}$  from 238.0m
- GTDD-22-0012 for 2.3m @ 1.21%  $\text{Li}_2\text{O}$  from 238.0m
- GTDD-22-0009 for 2.0m @ 0.50%  $\text{Li}_2\text{O}$  from 291.0m

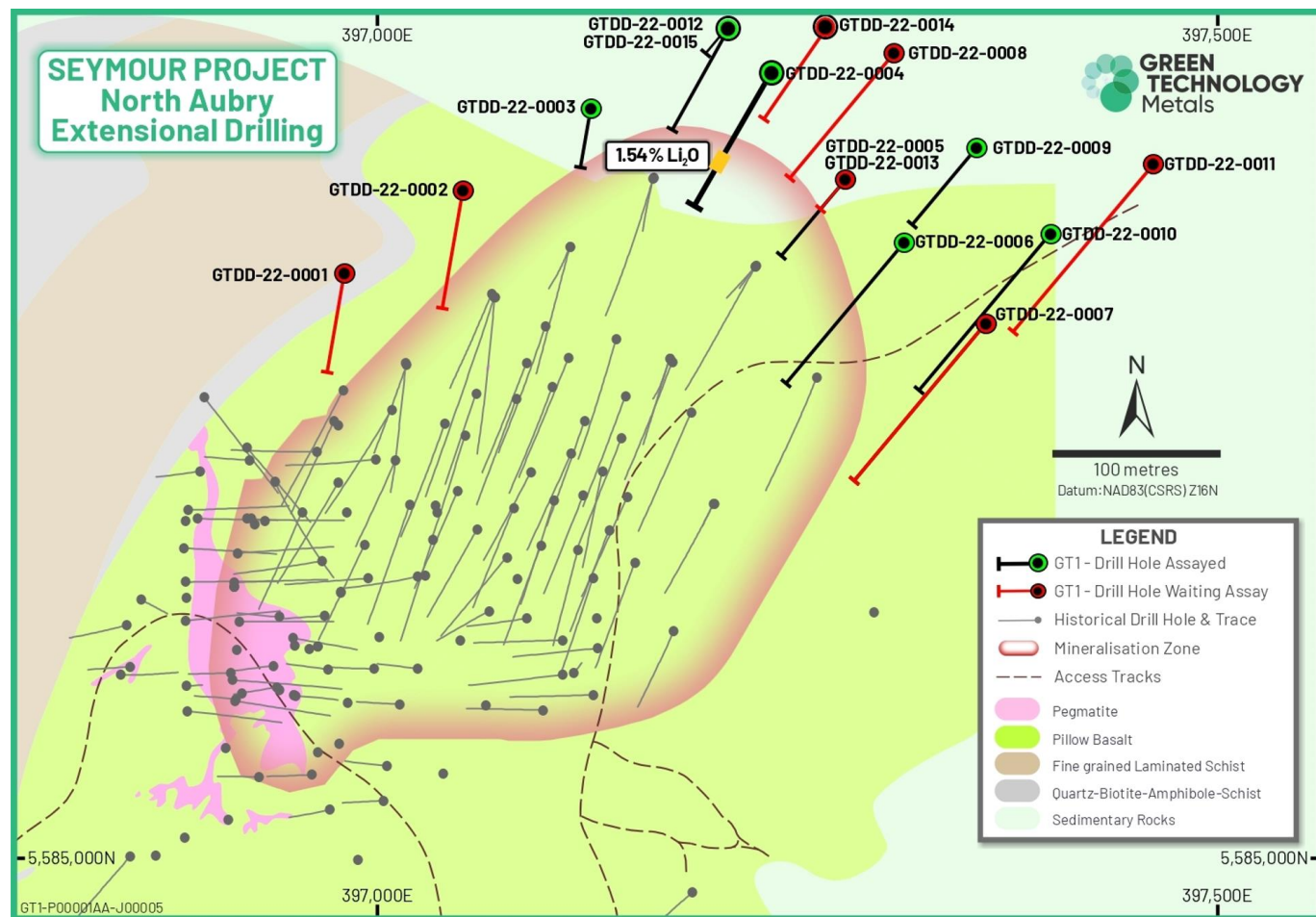
Results to date from the Phase 1 drilling at North Aubry suggest continuous mineralisation to depth with significant widths and lithium grades. Both the northern and down-dip extents of the pegmatite are open to further expansion. The two final holes drilled in the Phase 1 program, GTDD-22-0001 and GTDD-22-0002 (assays pending for both), are in the northern zone and to the west of GTDD-22-0003. These two holes returned thick, continuous pegmatite intervals of 11.2m and 10.7m, respectively (refer GT1 ASX release dated 17 March 2022). As a result of this ongoing northern extensional potential at North Aubry, GT1 plans to conduct further step-out drilling in the near term, with planning already underway for this work.

In relation to the disclosure of visual intersections of pegmatite, the Company cautions that visual intersections of pegmatite should never be considered a proxy or substitute for laboratory analysis. Laboratory assay results are required to confirm the widths and grade of visual intersections of pegmatite reported in the preliminary geological logging. The Company will update the market when laboratory analytical results become available.

## Phase 2 (Central Aubry zone) and Phase 3 (Pye prospect) drilling progress

As previously announced (refer GT1 ASX release dated 17 March 2022), both Phase 2 (Central Aubry zone) and Phase 3 (Pye prospect) drilling at Seymour have commenced.

At Central Aubry, 6 holes have been completed to date for approximately 897 metres. At the Pye prospect (located approximately 1 km east of the Aubry complex), 2 holes have been completed to date for approximately 304 metres.

There is currently no Mineral Resource estimate at either the Central Aubry zone or Pye prospect, with the existing Seymour Mineral Resource estimate comprised solely of the North and South Aubry deposits.

## CORPORATE

### OLP Joint Venture interest increased to 80%

During the quarter, GT1 exercised its right to acquire a further 29% interest in the Ontario Lithium Projects (Seymour, Root and Wisa Projects)(**OLP**). This took GT1's Joint Venture (**JV**) interest in the OLP to 80% (from its previous 51%). In exchange for the additional 29% interest, GT1 issued 4,049,520 fully paid ordinary shares to OLP JV partner, Ardiden Limited (ASX: ADV). This represented a scrip payment of A\$3.5 million at the 5-day Volume Weighted Average Price (VWAP) of GT1 shares up to and including 25 March 2022. These shares are escrowed until 10 November 2023.

### Balance sheet

GT1 had A\$16.1 million cash on hand as at 31 March 2022. Note that the Company undertook a successful A\$55 million equity raising before costs (at A\$1.05 per share) in late April (refer GT1 ASX release dated 28 April 2022 for full details).

### Share capital

Table 2 details the equity capital structure of the Company at quarter end.

On 28 Mar 2022, the company announced the issue of 4,049,520 ordinary shares as Second Tranche Consideration to increase interest in Ontario Lithium Projects as per Prospectus dated 16 September 2021. The shares are escrowed until 10 November 2023.

Performance Rights on issue comprise of:

- **Class A (Director)** – 2,000,000, vesting on GT1 achieving a volume weighted average price (VWAP) of A\$0.40 or more over 20 consecutive trading days, expiring 5 years from issue.

Class A, Class B and Class C Performance Rights all have a vesting conditions of 12 month, 18 month and 24 month continued service attached respectively.

In accordance with the terms of the issue of Performance Rights outlined in the Company's Prospectus, the performance hurdles for all 12.5 million Performance Rights have now been achieved (see GT1 ASX release dated 21 January 2022, *Performance Right Milestone Update*).

## Expenditure

## Exploration expenditure

Exploration and evaluation expenditure during the quarter was A\$1.986 million. Expenditure included claim acquisitions, desktop studies, field exploration, airborne geophysics, drilling and laboratory analysis.

## Related party transactions

During the quarter ended 31 March 2022, payments to related parties were A\$60,000 comprising of non-executive director fees and superannuation.

## Option Agreements

During the quarter, the Company entered into four option agreements to acquire further landholding in Ontario, Canada, via its wholly owned subsidiary Lithium Triangle Resources Ltd.

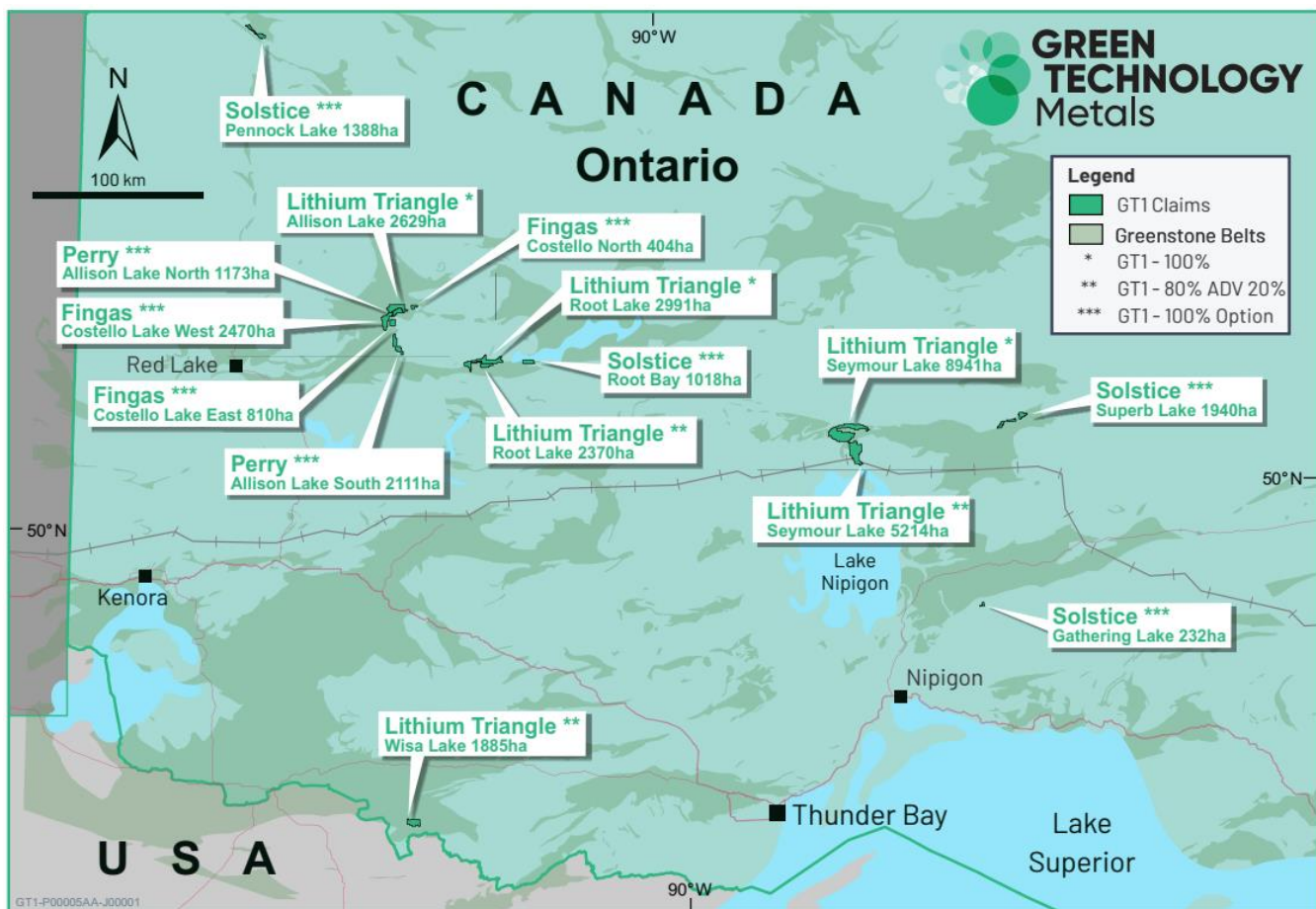


## Green Technology Metals (ASX:GT1)

GT1 is a North American focussed lithium exploration and development business. The Company's Ontario Lithium Projects comprise high-grade, hard rock spodumene assets (Seymour, Root and Wisa) and lithium exploration claims (Allison and Solstice) located on highly prospective Archean Greenstone tenure in north-west Ontario, Canada.

All sites are proximate to excellent existing infrastructure (including hydro power generation and transmission facilities), readily accessible by road, and with nearby rail delivering transport optionality.

Seymour has an existing Mineral Resource estimate of 4.8 Mt @ 1.25% Li<sub>2</sub>O (comprised of 2.1 Mt at 1.29% Li<sub>2</sub>O Indicated and 2.7 Mt at 1.24% Li<sub>2</sub>O Inferred).<sup>1</sup> Accelerated, targeted exploration across all three projects delivers outstanding potential to grow resources rapidly and substantially.



The Company currently holds an 80% interest in the Ontario Lithium Projects (Seymour, Root and Wisa) under a joint venture with Ardiden Limited (ASX: ADV). Refer to the Company's Prospectus (see GT1 ASX release dated 8 November 2021) for further details.
