8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not? No, the Company undertook a nearly 6,000 metre program which was completed during the quarter. The drill programme finished in July 2022. The remaining assay results from the final 11 holes are expected imminently and will be used to optimise the next stage of the exploration program. As drilling was completed in July, the monthly spend has been reduced considerably.	
8.8.2	Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful? The Company continually monitors market conditions and manages its cash reserves prudently. The Company has paused its drilling program at the Pickle Lake Gold Project, while it awaits the assay results on the remaining 11 drill holes and then has the opportunity to analyse those results to refine future drill targets. The Company regularly assesses its budgeted expenditure and the capital markets with a view to raising capital at a time most beneficial to long term shareholder value. Should additional working capital be required Ardiden would secure such funding by raising capital from equity markets, monetizing non-core assets and managing cash flows in line with available funds. Ardiden has demonstrated track record of successfully raising cash via share placements, share purchase plans, and monetizing non-core assets, to fund its operations. It has capacity under the ASX Listing Rules to issue further equity.
