EUR 120,000 collateral is held in an ADX VIE GmbH account with Volksbank. The facility consists of two parts: - EUR 500,000, interest-free until 31 July 2022, at which point interest charged at Euribor plus 0.75%, with the rate to be at least 0%; and payback every 6 months, started 30 June 2022 and ends 31 December 2024; and - EUR 630,000, 1% interest, same payback terms as above. As at 31 March 2024, repayments totalling EUR 753,333 have been made. <u>Loan Notes - Australia</u> ADX has \$1.5M of unsecured loan notes, on the following terms: - Interest payable at 8% pa on \$1 M of the loans; - Interest payable at 12% on \$500,000 of the loans and - Repayable by 11 January 2025.
