1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: Budgeted outflows for the June Quarter for Operating activities are \$80,000 and Capitalised Exploration are \$90,000. Future expenditure on Operating Activities and Capitalised Expenditure will depend on level of additional funding available.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Athena is waiting on additional funding from Goldway Mega Trade Limited. During the 9 months to 31 March 2020 Goldway have been issued shares to the value of \$1,037,900 (see Item 3.1 \$671,000 and Item 7.6 \$366,900).

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: The Company expects to be able to continue its operations and meet its business objectives as outlined in the March 2020 Quarterly Activities Report. As noted in 2 above Goldway Mega Trade Limited has been providing funding and further funding is expected in the current quarter.

The current operations predominantly consist planning the work required to obtain approval of the mining plan for the Byro Industrial Magnetite Project and reviewing sales and marketing opportunities in the markets identified in the Quarterly Activities reports. Furthermore, the Company constantly assesses its funding requirements in relation to its level of exploration activities to ensure that it is able to fund its future activities.
