## Navarre finalises 100% ownership of Tandarra gold prospect

### Highlights

- Navarre and Crocodile Gold complete conversion of earn-in right to a royalty interest in Tandarra
- Conversion ensures that Navarre enjoys full ownership of the prospective Tandarra prospect

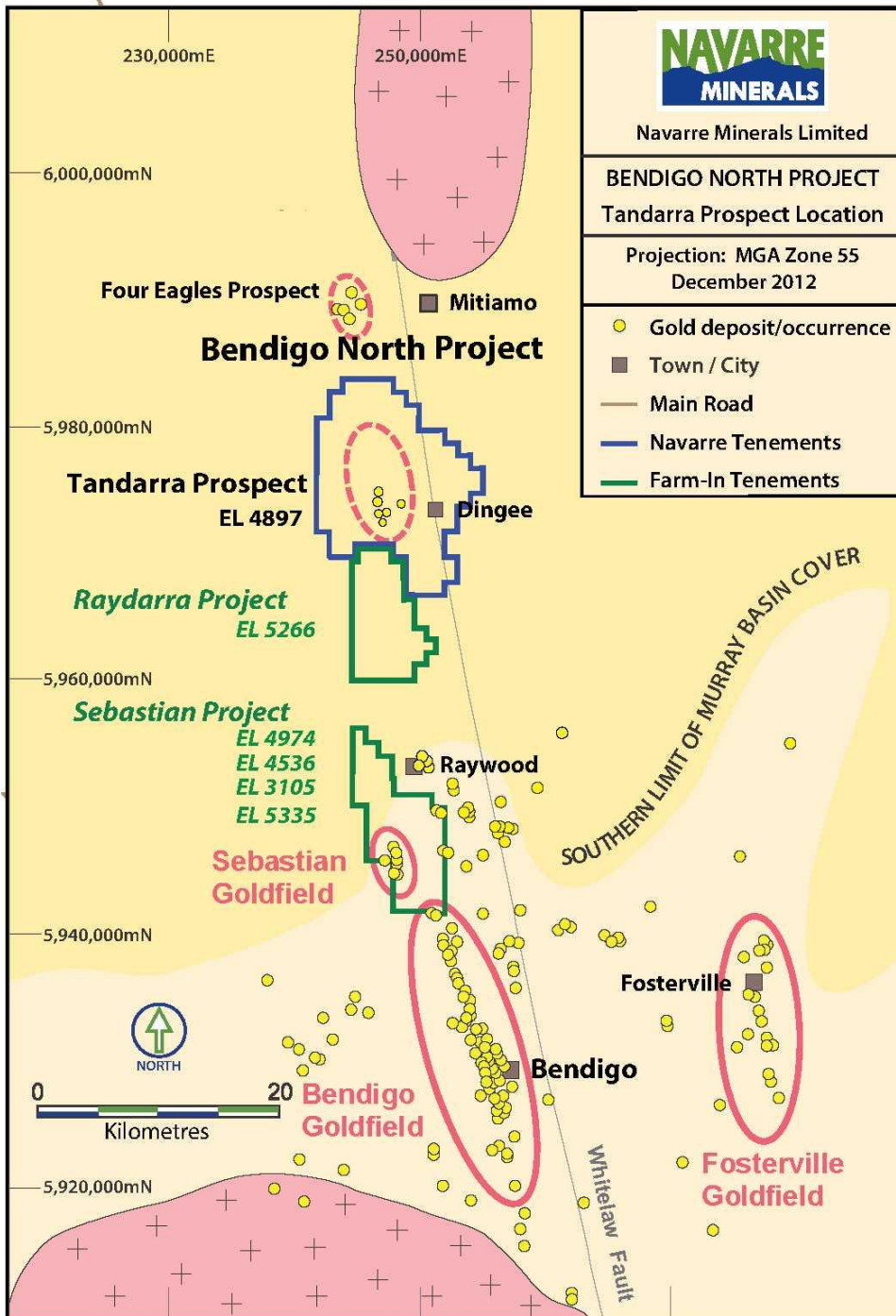


Figure 1: Location map of the Bendigo North group of gold projects

Victorian exploration company Navarre Minerals Limited (ASX code: NML) today announces that the Company and leading Victorian gold producer Crocodile Gold Corp. ("Crocodile") has signed formal documentation to finalise ongoing ownership of the Tandarra gold prospect (EL 4897), part of the Bendigo North Gold Project located 40 km north of Bendigo (Figure 1).

Navarre announced on 5 September 2012 that it had agreed to convert Crocodile's right to earn a majority interest in Tandarra into a 2% net smelter royalty ("NSR") over future gold production at Tandarra. That agreement also gives Navarre the right to buy back 1% of the NSR for \$2.0 million within four years, which would reduce the NSR to 1%.

"The agreement is a major step forward as it secures Navarre's tenure of one of Victoria's most outstanding greenfields gold exploration projects," commented Navarre Managing Director, Mr Geoff McDermott. "The project continues to move ahead under Navarre management and we welcome Crocodile being able to share in the upside of Tandarra should a commercial mining operation begin in the future."

Our assets include a recent gold discovery under shallow cover 40km from the 22Moz Bendigo Goldfield.
