8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: Exploration activities at Koongie Park have concluded, as we approach the wet season period in the Halls Creek region. There is likely to be limited significant exploration expenditure until late March/early April. In the event of the proposed Tanzanian acquisition completing (likely mid-December 2022) it is proposed to commence activities immediately.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: Yes. The entity has just completed its T1 raising of \$1.3M as part of the proposed Tanzanian transaction. Subject to shareholder approval, a further T2 raising of approx. \$2.2M is to be raised. The entity is confident that the T2 raising will be completed, subject to adverse market conditions.

Answer: The entity believes that successful completion of the T2 raising as part of the Tanzanian acquisition will provide sufficient funds (with existing cash resources) to continue operations and meet business objectives.
