

Soils at Mongers Lake Reveals New Gold and Ni-Cu-PGM Targets

- Soil sampling at Mongers Lake has revealed 2 new high priority prospects:
 - **Clay Pan:** Two large coherent gold-silver-sulphur-in-soil anomalies that extend for a combined 3km strike with other coincident pathfinder metals indicative of orogenic gold deposits
 - **Red Well:** Two large coherent nickel-copper-platinum-palladium-in-soil anomalies that extend for a combined 3 km strike indicating high prospectivity for Ni-Cu-PGM deposits
- Airborne magnetics indicates that the soil anomalies are highly coincident with prominent linear features that trend northwest
- These newly identified drill targets are strategically located within the richly endowed Yalgoo-Singleton Greenstone 20 km south of the 1Moz Rothsay gold deposit and 40km north of the >2Moz Mt Gibson deposit.
- Airborne EM review is currently underway in light of the Ni-Cu-PGM anomalies

Albion Resources Limited ("Albion" or the "Company") is pleased to announce that soil sampling has been completed and assays received on the Company's 100% owned Mongers Lake Project. The project covers the northern extents of the Yalgoo-Singleton Greenstone Belt located between the Mt Gibson and Rothsay Gold Projects in the highly prospective Murchison Province of Western Australia (Figure 1).

Recent compilation and interpretation work highlighted two high priority prospects Red Well and Clay Pan as being highly prospective for greenstone-hosted orogenic gold deposits, VMS style copper and base metal and magmatic nickel-copper-PGM deposits.

A total of 308 soil samples were recently planned and completed at Red Well and 229 soil samples at Claypan by XM Logistics. The samples were sent to Labwest Laboratories for ultrafine fraction (<2 micron) for gold and full suite multi-element assay.

Clay Pan

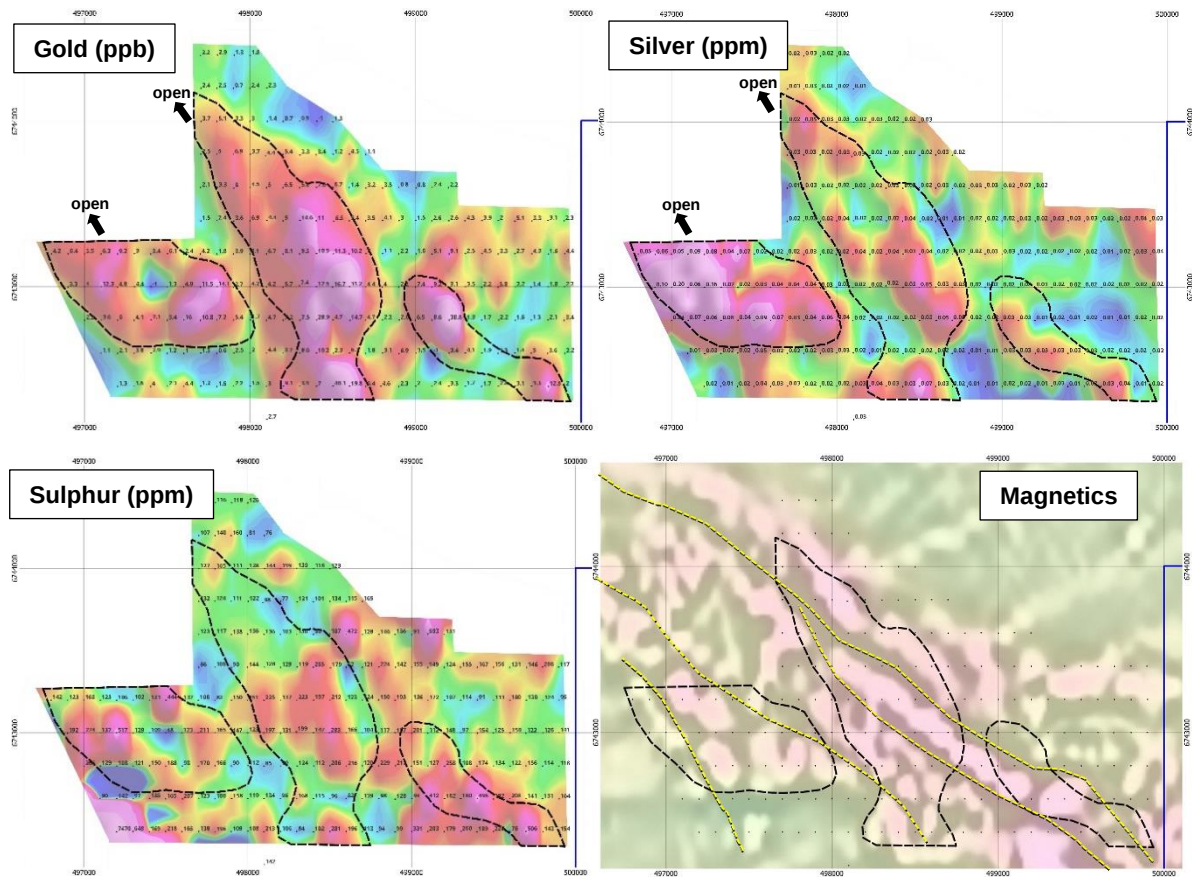


Figure 2A (top left) colour gridded Au-in-soil image. **Figure 2B** (top right) colour gridded Ag-in-soil image. **Figure 2C** (bottom left) colour gridded S-in-soil image. **Figure 2D** (bottom right) Airborne magnetic MrtpcMrtpap image showing interpreted lineaments (yellow dash) and soil anomalies.

Soil sampling assay results indicate a large, central coherent gold-in-soil anomaly over 5 ppb and up to 40 ppb and trends north-northwest (Figure 2A). The anomaly is coincident with highly elevated silver (Figure 2B) and sulphur (Figure 2C) and extends for at least 2km strike and open to the northwest. The western gold anomaly is not as well defined but extends for at least 900m and is highly coincident with very highly elevated silver, sulphur, bismuth and tellurium and again open to the northwest.

Airborne magnetic imagery indicates the elevated gold-silver-sulphur-in-soil anomalies are strongly associated with northwest-trending demagnetised lineaments that are possibly indicative of structures and associated alteration (Figure 2D).

These coincident Au-Ag-Bi-in-soil anomalies and interpreted structures are characteristic of classic structurally-controlled orogenic gold deposits typical of Archean greenstone terrains for example the Rothsay gold deposit located 20km to the north (Figure 1).

Red Well

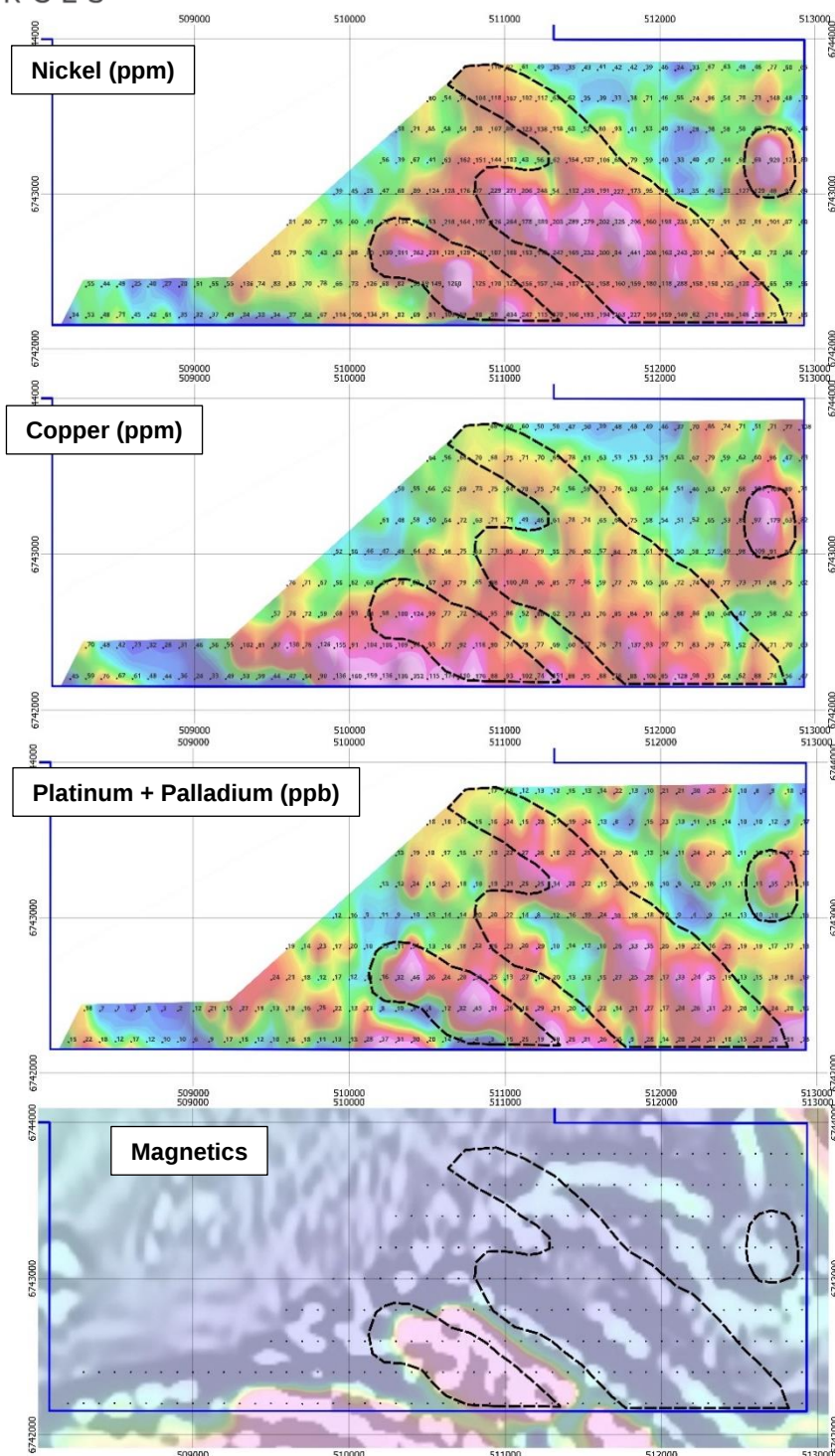


Figure 3A (top) colour gridded Ni-in-soil image. **Figure 3B** (second top) colour gridded Cu-in-soil image. **Figure 3C** (third from top) colour gridded Pt+Pd-in-soil image. **Figure 3D** (bottom) Airborne magnetic MrtpcMrtplap image showing and soil anomalies.

Soil sampling results indicates two coherent and coincident nickel-copper-platinum-palladium -in-soil anomalies that extend for 2km (central) and 1 km (western) respectively and trend consistently northwest (Figure 3). A prominent circular coincident Ni-Cu-Pt-Pd-in-soil anomaly with a diameter of around 200m also occurs to the east.

Airborne magnetics indicates that the anomalies are highly coincident with prominent linear magnetic features that trend northwest (Figure 3D).

These geochemical Ni-Cu-PGM anomalies and coincident magnetic features are characteristic of classic magmatic nickel-copper-PGM systems typical of Archean greenstone terrains such as for example the Andover Ni-Ci-PGM deposit hosted in the Archean aged Andover Complex in the Pilbara (Azure Minerals Limited)

Further Work

These newly defined consistent and coherent Au-Ag-S and Ni-Cu-PGM anomalies at Clay Pan and Red Well are highly significant and strongly support the potential for gold and Ni-Cu-PGM discoveries on the project. Satellite imagery is being assessed to evaluate the extent of outcrop the area to justify rock reconnaissance sampling over the soil anomalies in conjunction with other reconnaissance rock sampling planned on the project.

In addition, publicly available airborne EM data is available over Red Well which is currently being evaluated in light of the significant Ni-Cu-PGM anomalies. This work will be complete in the coming weeks which will assist in evaluating where drill permits will need to be lodged to conduct reconnaissance percussion drilling later in the year.
