

Resubmission of Notice of Initial Substantial Holder

Appendix to Form 603

This appendix accompanies the re-lodged Form 603 submitted to ASX and provides clarification regarding a form completion error in the previously disclosed number of securities held by the notifying holder. This document is provided to ensure the market is fully informed in accordance with section 671B of the Corporations Act 2001.

A Form 603 was previously lodged with ASX in respect of the notifying holder becoming a substantial holder. Following lodgement, it was identified that the form was completed incorrectly, with the company's outstanding units entered in error as the number of securities held by the notifying holder.

The previously lodged Form 603 therefore did not reflect the correct number of securities held by the notifying holder at the time of the relevant event.

The notifying holder confirms that this correction does not relate to any acquisition, disposal, or change in relevant interest beyond those previously disclosed, and that the issue arose from a data entry error in completing the form.

This re-lodged Form 603 replaces the Form 603 lodged on **8 April 2026** and reflects the correct number of securities held.

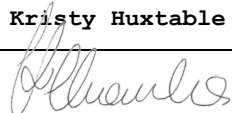
